### Monday, January 25: [Depart to Honolulu \(Oahu\)](#)

Depart for a Hawaiian adventure. Upon arrival, you will be greeted with a welcome lei and transferred to the hotel for check-in. The rest of the evening is at leisure.

Our home for the next three nights is the Aston Waikiki Beach Hotel, an urban-Hawaiian themed hotel located directly across the street from the world-famous Waikiki Beach. Restaurants, shops and many activities are within walking distance.

### Tuesday, January 26: [Waikiki \(Oahu\)](#)

This morning, take an early morning tour of Honolulu. Our tour will include Pearl Harbor and the Arizona Memorial, which was created to honor those who died in the Japanese surprise attack on December 7, 1941. Most of the 2,390 people who perished that day were aboard the USS Arizona. The tour continues with a drive through the National Cemetery of the Pacific and King Kamehameha statue.

These majestic humpbacks migrate to the warm waters of Hawaii for the winter and spring calving season. Our expert will explain their reproductive behavior, mating competition among the males and other unique whale characteristics. A whale sighting is guaranteed! **Meals: B**

**Tuesday, February 2: Maui**

This morning and afternoon will be free for you to discover "The Valley Isle."
