The Board of Education met for their regular scheduled meeting at 7:33 p.m. on March 16, 2011 at the Seneca Grade School North Campus Board Room.

Hearing of Teachers: Julie Morris, 6<sup>th</sup> grade science and social studies teacher, talked about the geography fair. Students dressed in ethnic costumes, brought in food and gave presentations on different countries. Students have also started a inter discipline unit where all classes have centered there projects around March Madness. Students may be researching the colleges, team statistics, sport medicine, or designing a graph to support their findings. Future units include an embryo project and the measure of soil acidity. Chamlin & Associates are finishing up the site survey with elevation of entrances and ramps for the new building.

Principal McGhee reviewed that preschool/kindergarten screening has been completed by LEASE with seventy children screened this year. ISAT test are completed and will be sent back tomorrow. She was very pleased with the good attendance by students. The fourth grade recorder concert was held on Wednesday and Mr. Richards and his students did a fine job, with many parents and family members in attendance. Two kindergarten teachers just returned from the Illinois ASCD Conference and several teachers are heading to Springfield on Thursday for the Annual Reading Council Conference, "Literacy Outside the Box", both conferences prove to be very beneficial to our teachers. Principal McGhee also mentioned that try-outs for the PSO talent show will be held March 17<sup>th</sup>, with the actual show being preformed on Wednesday, March 30<sup>th</sup>.

Supt. Misener gave the South Campus updates. He congratulated the math Team who won the IVC Math Contest.
