Hearing of Teachers: Vicky Garrison, speech teacher, gave summer school students speech services twice a week for three weeks. She will have roughly fifty students receiving services during the upcoming school year which is an average number. She is also very excited and looking forward to being in her new classroom this year. Cory Yandell, 6<sup>th</sup> grade teacher, is into his third week of coaching baseball and thing are going well. He commented on how nice the south campus gymnasium looks and is looking forward to coaching basketball on the new floor.

Supt. Misener reviewed the cuts in federal and state money and the decline of income on investments which have all contributed to the decrease in income revenue. Baker moved to approve the 2011-2012 tentative budget and to hold the budget hearing at 6:55 p.m., prior to the

Supt. Misener highlighted construction updates. The school will be ready to open on time. A small list of items need to be finished before school starts but classrooms are ready and the gym has been cleaned out and furniture and books are back in their classrooms. The walkway between the north and south ends of the North campus is complete with the exception of added a few doors. It was estimated that 2/3 of the renovation project is complete and the balance will be finished over break and next summer when students are not in attendance. The Storm Sewer project will be completed this week. Craig Wright, architect, explained the new construction. Contractors are underlying the plumbing and electrical. Next the concrete slabs will begin being poured in the new addition. Structural steel will be arriving and work will be starting on the east end working to the west.

Stu Whitt set the timeline and highlighted the accounts of what has brought the Seneca Grade School to the transfer of tort funds and abatement of taxes levied for the capitol fund project. The sale of the working cash bonds will be delivered September 1<sup>st</sup>, 2011 and will be abated by August 1<sup>st</sup>, 2012. He reviewed the 1.4% interest rate that will be paid and the agreement with Vezzetti Capital Management and other expenses related to the transaction. Tax exempt status and closed transaction will keep fees to a minimal.

Baker moved to approve the Bond Purchase Agreement for the sale of \$4,300,000 Working Cash Bonds, Series 2011, to Vezzetti Capital Management LLC, as presented; seconded by Sangston.

Principal Severson and Principal McGhee will be having a district wide meeting with aides to answer any questions they may have.

Principal McGhee discussed how construction has impacted the North Campus. Teacher did get in their rooms a couple days earlier than what they original thought. Therefore, teachers got a jump on getting into their classrooms and a lot has happened in a short amount of time. Faculty and staff will be going over the many changes that will affect students this year.
