- to participate in European Commission Fast Track Committee meetings;
- to be updated on ERIK ACTION initiatives and events;
- to access ERIK ACTION documents from the Project Open intranet.

The Regional Government of \_\_\_\_\_ understands that ERIK ACTION Observer Regions will participate in these activities with their own financial and human resources. They will not receive funding from INTERREG IVC.

The Regional Government of \_\_\_\_\_ understands that Observer regions are not permitted to attend personnel exchanges and that specific personnel exchanges with Observer regions will not be organised with ERIK ACTION funding. Any such activities would involve bilateral agreements between the Observer region and the ERIK ACTION partners and would be funded with their own resources.

The Regional Government of \_\_\_\_\_ accepts that ERIK ACTION Observer Regions have the following obligations:

- to provide all requested information and documentation before participating in ERIK ACTION activities;

- to follow EC regulations concerning participation in an co-funded project (see INTERREG IVC Manual).

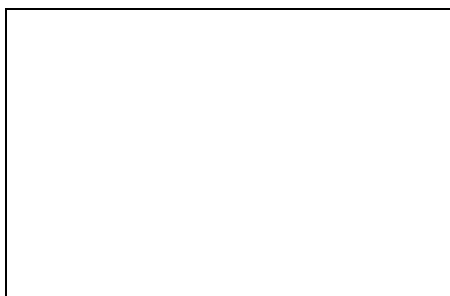
