To obtain an IRS tax return transcript, go to <u>www.IRS.gov</u> and click on the "Get Transcript of Your Tax Records" link or call 1-800-908-9946. Make sure to request the "IRS tax return transcript" and not the "IRS tax account transcript." You will need your Social Security Number, date of birth, and the address on file with the IRS (normally this will be the address used when the 2014 IRS tax return was filed). It takes up to three weeks for IRS income information to be available for electronic IRS tax return filers, and up to eight weeks for paper IRS tax return filers. You may also visit your local IRS office and request a tax return transcript.
