## Tidewater Virginia USBC $201154^{\text {th }}$ Annual Women's Tournament

ELIGIBILITY - Entry will be open to members of the Tidewater Virginia USBC only. Non-members residing within the jurisdiction of this Association may become eligible by purchasing the appropriate membership. Non-members not residing within the jurisdiction of this Association are not eligible to participate in the tournament.
AVERAGE - Entrants shall use their highest 2009-10 USBC yearbook average. You may use your average from another association if verified by the Secretary of the Association. If no 2009-10 yearbook average, highest current average for 21 games or more as of January 1, 2011. If none of the above, the highest summer 2010 average based on 21 games or more may be used. If none of the above applies, scratch average of 210 will be used. We do accept a USBC Tidewater Youth 2009-10 yearbook average. If verification is not received prior to the time of bowling, an average of 210 will be used.
MULTIPLE ENTRIES - An entrant may enter the team event two times. Not more than two (2) players on a team may bowl together more than once. You may enter Singles/Doubles only once. If you enter Singles you must enter Doubles The first appearance in the Team Event will count toward your ALL EVENTS SCORE.
TIES - First place ties in any event require a one game roll-off within ten (10) days. Date of playoff will be set by the Tournament Director and the expense of bowling will be paid by the Association. When ties for other than first place occur, prize money will be combined and divided equally among the tied positions. If multiple participants are duplicated in the team, only members not duplicated may bowl in the roll-off. If a tie occurs in scratch scores for first place in any event, co-champions will be declared.
ENTRY FEES - Full payment for all entries must be submitted with application. $\$ 22.00$ per person for each event: (Team/Doubles/Singles): Lane Expense Fees, $\$ 12.00$, Prize Fees, $\$ 10.00$, per person. Team Doubles/Singles will be at least one prize for each six (6) entries. Optional All-Events, $\$ 3.00$. Prize Fees will be returned 100 percent at the rate of at least one prize for each eight (8) entries. Return checks will be subject to a $\$ 25.00$ return fee.
LINE UP - The line up will be the same as listed on the entry form. Any player arriving after a game has started will be allowed to bowl and the score to count beginning in the frame then being bowled. No points will be given for frames missed. Doubles are bowled immediately following Singles Event. If one bowler does not show, the individual present will bowl her singles and if her partner is still not present, and a substitute is not available, the member present will be permitted to bowl doubles in order to qualify for All-Events.
SUBSTITUTES - Substitutes should be reported as soon as possible. Any substitute will be entered on the entry form in the same position as the original entrant. In case of emergency after the game has started, a substitute, if available, shall be allowed in the team and/or doubles event only. If no substitute is available, only the actual score of the frames bowled shall count. A substitute will not be required to reimburse the original entrant with the entry fee, nor will the substitute be expected to give the original entrant any prize money or award she may win.
SCHEDULE - Entries will be scheduled in order as received. Entries close on February 11, 2011. No changes except for emergencies.
SCORING - Automatic scores will be official during progress of the games. Only completed scores sheets (recap sheets) filled in by the team captain and/or score keeper will be accepted. If score sheets are not turned in for any event and a print-out is not available, you will receive a zero for that event. Any errors must be reported within 24 hours to the tournament office.
DISQUALIFICATION - A team or doubles using a non-certified or inter-association bowler will be disqualified. Averages listed lower than actual average will result in individual and team disqualification. Averages listed higher will not be reduced downward. A disqualified individual or team forfeits all entry fees and rights to prize money.
ATTIRE - Members are requested to wear suitable attire when participating in the tournament. Skirts, slacks, shorts and walking shorts are preferred.
MEMBERS - Before leaving the bowling area you are assigned while any event is in progress, please inform the team captain or tournament official. If not informed, it could result in a zero for the frames missed.
ENTRANTS - The names which appear or their replacements agree the Tidewater Virginia USBC, its officers and agents shall be liable only to the extent of returning entry fees if and when entrants shall be prevented from bowling any event in the tournament through delay, unexpected yet necessary schedule changes, or premature termination of the tournament brought about by anything beyond the control of Tidewater Virginia USBC officials, such as war, fire, strikes, etc.
