Implementation Status Overview

The Registration Project is achieving effective implementation after the institutional reorganization that resulted in the creation of RosReestr. It has initiated procurement of the IT and communication systems for country-wide deployment and is undertaking a number of institutional development tasks to integrate the parts of RosReestr. The May 2011 mission recognized that organizational changes following the unification of registration, cadastre and cartography services, as well as the impact of changes in legislation relevant to the unified system, had constituted the main reasons for delays from the original implementation plan and disbursement schedule. The World Bank acknowledged the prudence of

RosReestr in sequencing the procurement of IT systems after institutional and legal aspects were clarified to ensure efficient use of Loan proceeds. On this basis there was agreement that the current procurement plan represents a realistic calendar and that disbursements will be benchmarked according to its fulfillment. Adherence to the Procurement Plan (and the Action Plan) scheduled is therefore essential for achieving project objectives. There will be continuous dialogue and communications amongst the Bank team, RosReestr and PIU to maintain the momentum.




