MINUTES OF MEETING NO. 4

The Fourth Meeting of the Council of The Corporation of the Township of Uxbridge was called to order by Mayor Shepherd at 7:00 p.m.

I. DISCLOSURES OF PECUNIARY INTEREST AND THE GENERAL NATURE THEREOF.

There were none.

II. DELEGATIONS

a) KATHY WASYLENKY, PRESIDENT, LUCY MAUDE MONTGOMERY SOCIETY OF ONTARIO

Ms. Wasylenky presented an update on the activities of the Lucy Maude Montgomery Society and the progress at the Leaskdale Manse Historic Site and the Leaskdale Church.

The Church Manse is now being furnished with period pieces either acquired by the Society or 'on loan' from others. Through 2007, there was a total of 900 visitors to the site as the result of various events and Ms. Wasylenky identified the positive impact attributable to the activities of a summer student at both sites.

Throughout 2007, many renovations have been completed within the former Church building which has been used in conjunction with numerous events, some of which show the potential for revenue generation. Ms. Wasylenky reminded Council that the Society had recently made a \$20,000 payment toward the loan from the Township which was in addition to the regular monthly installments. The Society has also received a \$24,000 grant from 'New Horizons' that will be used for specific renovations as well as a 'Looping Visual Presentation' system and a Trillium Grant application has been submitted which, if approved, will be used for major renovations and accessibility features in the Church as well as a cedar shake roof on the Manse.

Ms. Wasylenky thanked Council and the Township for their ongoing support and cooperation and expressed her hope of moving forward to the 100th Anniversary of the arrival of Lucy Maude Montgomery in Leaskdale in 2011. She then outlined the events scheduled for 2008, both local and national. In conclusion, Ms. Wasylenky asked that Council consider the Society's request for funding as well as a

declaration of 2008 as "The 100 Years of Anne". She also asked that a display area be allowed in the Town Hall for the balance of the 2008 year.

MOVED by Councillor Mikuse, SECONDED by Councillor Ballinger "THAT Council for the Township of Uxbridge declare 2008 to be "The 100 Years of Anne of Green Gables" in the Township of Uxbridge."

Councillor Mikuse advised those present that the Society would be participating in an "Anne of Greene Gables" feature event for the duration of the 2008 Canadian National Exhibition and that there was also to be an "Uxbridge Day" celebration.

b) JOEL VANVEGHEL & DONNA VANVEGHEL re Request for Reduction for Cash-in-Lieu of Parking – 1 Main Street South

Mr. VanVeghel advised Council that he and his mother, Donna VanVeghel, were planning to open a restaurant at 1 Main Street South. He indicated that they were long-time residents of the Township and were very involved in various community activities. He expressed their excitement about the Downtown Revitalization and how they felt that this business venture could contribute to it but the current Township parking requirements were prohibitive. He indicated that they had met with the Manager of Development Services and were advised that the business would require nine (9) parking spaces. Currently, the property has only two (2) spaces and the Cashin-Lieu policy would require a payment of \$2,500 per additional space which would mean a total outlay of \$17,500. Mr. VanVeghel asked if Council could recommend an alternative to this requirement, as had been allowed for other restaurant locations in the Downtown area.

MOVED by Councillor Herrema, SECONDED by Councillor Ballinger "THAT staff be directed to work with Joel and Donna VanVeghel in order to achieve a solution for the parking deficiency at 1 Main Street South that is consistent with that allowed similar businesses in the Downtown area and to bring a recommendation back to Council."

c) ANNE HOLMES re Accountability and Transparency relative to Bill 130.

Ms. Holmes presented Council with her interpretation of Bill 130 and its implications for the Township of Uxbridge, one being the possibility of the formation of a Lobbyist Registry. She reviewed features of the legislation that should ensure public participation in Township matters as well as deter any devolution of power. She then voiced her concerns regarding the role of Uxbridge Naturally in the matter of the Tannenbaum lands and, further to this, also expressed concern about the future of the Tannenbaum lands and the possible financial impact she feels they could have on the Township along with the impact of those properties that she understands to be not producing their proportionate share of current tax burdens. Ms. Holmes concluded her deputation by requesting information concerning Council's position on the acquisition and management of the Tannenbaum lands, who would be responsible for maintenance costs on these lands should they be acquired by the Township, as well as the Township's policy and long-term plans for the protection of wildlife habitat and plant species on Township lands. She further questioned the Township's policy on the promotion to the Toronto Region Conservation Authority on protection, preservation and conservation on lands controlled within the Township. Ms. Holmes requested a timely response to her queries.

- c) Councillor Ballinger advised those present that the Family Day events at the Legion building were most successful in spite of the damaging effect of the rain on Elgin Pond and the scheduled 'Family Skate'. He expressed his hope for the continuation, next year.
- d) Councillor Herrema advised those present that the Federal Government had just announced an additional \$12 million funding for the protection of Lake Simcoe. This is in addition to the \$18 million already identified. Monies will be used, in part, for the reduction of phosphorous, buffer zones and stormwater management.
 - He further advised that, during the Ontario Good Roads Association Annual Conference this week, Premier McGuinty announced an additional \$150 million 'top-up' for the Municipal Infrastructure Investment Initiative Program. Councillor Herrema suggested this added money may be the amount required to cover the applications received to date and that the Uxbridge submission might be successful.
- e) Councillor Ballinger advised those present that the event to recognize Bob Harrison was 'sold out'. He thanked the community at large for its overwhelming support.
- f) Councillor Ballinger reported that the ice thickness on Elgin Pond was currently eleven inches thick.
