Terms and rules:

- You must be a member of the Spokane Gun Club to use our RV Facilities. All participating shooters at SGC events are members for the duration of that shoot. Members of other shooting clubs are granted membership privileges upon presentation of valid current membership card. Current Spokane Gun Club members may sponsor quests for limited stays.
- Maximum stay for non-shooters:14 consecutive days.
 Certain specific named individuals with prior relationship and agreement with the Club are exempt from this restriction. Board of Directors approval is required for monthly stays.
- Pets must be restrained or leashed in accordance with Spokane County and other legal regulations. Specifically, Spokane County law requires that owners must clean up pet waste.
- Quiet time 9:00pm 7:00am. No generators, loud music or noisy outdoor activities 9pm–7am.
- SGC is a federally chartered organization. Federal laws apply. Specifically, Federal DEA regulations of marijuana and other drug use supersede Washington laws on this property.
- RV park renters are "Facility Users" and must sign a Hold Harmless Agreement at move-in which is effective for the full length of their stay.
- RV Park renters are responsible for all actions of their group. All guests are bound by all rules.
- Limit 1 RV or tent and up to two (2) personal vehicles per site. No washing of vehicles. No working on vehicles beyond immediate repairs necessary to remove them.
- Garbage containers and dumpsters are for everyday household trash <u>only</u>. No large boxes, lawn chairs, televisions, rugs, grills, crashed airliners, microwaves, leaves or branches, etc.
- Public intoxication, excessive profanity, vandalism or disorderly behavior will not be tolerated.
- No campfires
- SGC reserves the right to refuse or discontinue service to anyone for any reason or without giving reason, without refund or advance notice.
