Dear Planning Committee Members

It has recently come to the attention of the SCCA that BC Timber Sales has proposed cutblocks in the Chapman Landscape Unit and the Howe Landscape Unit. Several of these blocks are of concern to us.

1. High Elevation Forest of the Dakota Creek and Roberts Creek headwaters.

BCTS is proposing several large blocks (A84612 and A79517) in high elevation, and potentially ancient forests located within the headwaters of these two creeks. This appears to be age class 9 (greater then 250 years old) timber in the Mountain Hemlock moist maritime BEC zone containing significant amounts of ancient yellow cedars. Logging within this zone is timber mining as regeneration takes centuries and therefore cannot be considered a sustainable forestry practice. As well, these remaining enclaves of ancient of biodiversity are not replaceable within several lifetimes and should be managed accordingly. The amount of old growth forest remaining on the lower Sunshine Coast is extremely low and worth retaining for multiple reasons ranging from habitat, to water quality, to tourism. Additionally, two blocks identified as A84612 will further separate two wildlife habitat areas set aside for Marbled Murrelets along the ridge between the Dakota drainage and Roberts Creek headwaters. Also, the Chapman Landscape Unit as yet has not had the benefit of the establishment of Wildlife Habitat Areas. This is a long standing oversight in need of attention. These areas, once designated, set aside areas for Ungulate Winter Range, Amphibian Habitat, Marbled Murrelet etc, offering some protection for these important habitats.

2. Proposed Elphinstone Park and Roberts Creek Public Interface zone

BCTS has proposed several cut blocks with this area. As everyone here is well aware, this area on the lower slopes of Mt Elphinstone has long been desired by the Sunshine Coast community as a park and has been used by a large contingent of our community for various recreational and other purposes.

Presently the SCCA is assembling a map of existing data to determine the optimal boundaries for such a park based on values of biodiversity, age class etc. We have also been advised that the Elphinstone Logging Focus is working to reassess the values found within the originally proposed park area. Funds for both of these efforts have already been set aside. This area has been greatly impacted by the recent logging activities such as EW002 which was a valued component of the eastern corner of the proposed park area. Further logging activity will degrade the value of the area as whole and likely affect the logged areas potential for inclusion within a park.

Our request.

There are significant values, both to the environment and to the community found with the two areas mentioned above. The SCRD has the opportunity to review and speak to the needs and concerns of the community that may be impacted by these cutblocks. We respectfully ask that you, as the planning committee, recommend to the board that the submission to BCTS include the following

1. That BCTS remove blocks DK 042, 043, 044, 044b, and DK045 from its proposed sales plans as they are within age class 9 forest.

2. That BCTS discontinue its logging activities within the Mountain Hemlock moist maritime BEC zone.

3. That BCTS identify and move forward, with all tenure holders, WHAs within the Chapman Landscape Unit.

4. That BCTS support a moratorium on the logging of Mt Elphinstone Slopes until such time as a comprehensive land and resource use plan is completed to determine the best uses of these lands and the values found upon and within them, to meet the future needs of the community of the lower Sunshine Coast and surrounding region.

BACKGROUND

On June 14th, the Regional District received a referral from the Recreation Site and Trails Branch, of the Ministry of Forests, Lands and Natural Resource Operations who were seeking comments regarding eight (8) seaside recreation sites in Howe Sound: three (3) of these sites are within the Squamish Lillooet Regional District, two (2) sites are on Gambier Island and three (3) sites are on the West side of Howe Sound. Planning staff referred these three proposed sites to June 25th Area F APC, July 3rd NRAC meetings and our Parks Department before sending comments to the Crown.

A copy of the Area F APC staff report is in Attachment A (without all the maps); a copy of the letter to the Crown is in Attachment B.

At their July 11th meeting, the Community Services Committee made the following recommendation:

Recommendation No. 15 Recreation Sites Howe Sound

The Community Services Committee recommended that the verbal report from Director Turnbull regarding Howe Sound Recreation Sites with respect to process be received and this issue be referred to the July 18, 2013 Planning and Development Committee as a late item.

DISCUSSION

The Crown requested comments back by July 14th. Staff had a very short turnaround time to meet the deadline for APC and NRAC referrals. In fact, staff asked NRAC to hold an extra meeting in July to accommodate this referral and another. Staff followed the following board policy regarding this referral.

128/02 <u>Recommendation No. 15</u> BC Assets and Land Corporation Application THAT the Staff report dated February 21, 2002 regarding BC Assets and Land Corporation Application Referrals be received;

AND THAT referrals from BCAL regarding licence of occupation applications be dealt with in the following manner:

1) An initial referral be sent to the Area Director in whose area the application is located;

- 2) Where BCAL's 30 day time frame does not permit a review opportunity by either the APC or the Planning Committee, Planning and Development Division staff will compose a response letter to BC outlining objections, issues and relevant concerns from the Regional District's perspective based on SCRD board policies, previous referral responses, relevant OCP policies and bylaws;
- 3) For information purposes, staff will then provide a copy of this letter and the application to both the director and the APC in whose area the application is located.

Note that staff didn't have an opportunity to send an initial referral to the Area Director before the APC viewed it. The Area F Director attended the June 25th APC meeting in which this referral was discussed.

BACKGROUND

On June 14th, the Regional District received a referral from the Recreation Site and Trails Branch, of the Ministry of Forests, Lands and Natural Resource Operations who are seeking comments regarding eight (8) seaside recreation sites in Howe Sound: three (3) of these sites are within the Squamish Lillooet Regional District, two (2) sites are on Gambier Island and three (3) sites are on the West side of Howe Sound. The SCRD will respond to the three sites within our Regional District: Bain Creek, Thornborough Channel and Islet View.

DISCUSSION

The intent of these sites is to provide a safe place to provide moorage for recreational watercraft connected with an easy days paddle across Howe Sound. Please find attached maps showing the areas of interest.

Planning staff some general comments:

- The concept of a marine trail in Howe Sound has been around for many years. Staff support the concept.
- Howe Sound is well known for strong outflow winds and travel between these sites may not be ideal during a course of a trip.
- Each recreation site should be near a source of fresh water.
- The Bain Creek site is adjacent to a hydro line and neighbours DL 3343, which is privately held. The owners of DL 3343 also hold a Crown foreshore licence for log handling and storage.
- The Thornborough Channel site is adjacent to a hydro line and is within 2 km of private land (DL 2469). It is also near a proposed gravel mine on private lands (Burnco, DL 677). This site is approx 6km from the Bain Creek site (along the shore).
- The Islet View site is adjacent to a hydro line and is within 1.3 km of private land (DL 1435). This site is approx 7.5km from the Thornborough Channel site (along the shore). A helicopter ski operation holds tenure above the power lines. The Squamish Band has a reserve on islands nearby.

CONCLUSION

Planning staff are requesting the APC to review Crown Referral for proposed recreation sites Islet View 169896, Thornborough Channel 169898 and Bain Creek 169900 along West Howe Sound for comment. APC comments will be incorporated into a SCRD response to the Ministry of Forests, Lands and Natural Resource Operations.

The Recreation Sites and Trails division of the Ministry of Forests Lands and Natural Resource Operations is seeking comments from adjacent interest holders to the proposed establishment of 8 seaside recreation sites in Howe Sound. These 8 sites are intended to provide a rustic, camping experience for sea kayaking. Recreational users will access and egress these sites from the sea and no development activities are planned at this time. This proposal is intended to provide a network of campsites connected within an easy days paddle across Howe Sound and is further intended to provide connectivity to the greater Marine Trails network being established throughout British Columbia's coast. Recreation Sites and Trails BC branch intends to legally establish these sites under Section 56 of the Forest and Range Practices Act (FRPA).

Establishment of a recreation site under Section 56 of FRPA designates the site as a managed recreation feature in an integrated land base so that it is considered in resource management activities. This allows for the management of the recreation feature under the Forest Recreation Regulations by Recreations Sites and Trails BC. This ensures that the public has access to the feature and that any future development which will affect the feature is managed in a way that incorporates the objectives of the established recreation feature into account.

Five of these eight sites fall within the Sunshine Coast Regional District while the other 3 fall inside the Squamish Lillooet Regional District. Recreation Sites and Trails BC would like to inform the SCRD of the proposed designation of these sites and to learn what concerns there may be. The five sites that fall within the SCRD are listed below and are shown on the accompanying overview and detailed maps.



Re: Ministry of Forests, Lands & Natural Resource Operations (MFLNRO), Recreation Sites and Trails Branch, Application Files 169900, 169896 and 169898 for recreation sites along west Howe Sound

This will acknowledge receipt of the above Ministry of Forests, Lands & Natural Resource Operations (MFLNRO) referrals. Due to MFLNRO's limited timeline, the Sunshine Coast Regional District (SCRD) Board will not be able to make a resolution regarding the above application. Therefore, the following comments are from Regional District Planning and Development staff.

Planning staff will not be providing comments on the two sites on Gambier Island (Ramillies Channel and Latona Passage). Islands Trust is the agency responsible for planning on Gambier Island. It would be more appropriate for Islands Trust to comment on those sitses. The Sunshine Coast Regional District will respond regarding the three locations on the mainland in our area: Islet View, Thornborough Channel and Bain Creek.

Planning staff have some general comments:

- The concept of a marine trail in Howe Sound has been around for many years. Staff support the concept.
- Howe Sound is well known for strong outflow winds and travel between these sites may not be ideal during a course of a trip.
- Each recreation site should be near a source of fresh water.
- The Bain Creek site is adjacent to a hydro line and neighbours DL 3343, which is privately held. The owners of DL 3343 also hold a Crown foreshore licence for log handling and storage.
- The Thornborough Channel site is adjacent to a hydro line and is within 2 km of private land (DL 2469). It is also near a proposed gravel mine on private lands (Burnco, DL 677). This site is approx 6km from the Bain Creek site (along the shore).
- The Islet View site is adjacent to a hydro line and is within 1.3 km of private land (DL 1435). This site is approx 7.5km from the Thornborough Channel site (along the shore). A helicopter ski operation holds tenure above the power lines. The Squamish Band has a reserve on islands nearby. The Band should be consulted.

Planning staff also sent these referrals to two advisory committees. The West Howe Sound Advisory Planning Commission had the following comments:

- My concern is the size of the recreation sites. The smallest one is four hectares. Why do you need so many hectares for people to come in and camp?
- Where are the archaeological sites?
- Think it is a great idea, but it is taking a heck of a lot of land.
- Bain Creek site: concern that reserving the entire part would prevent access to Crown lands beyond, as on either side are steep rock faces.
- Concern about eventually going from being a primitive site to a Class A park. What is the process before it gets from the proposed tenure to a Class A park?
- What is the length of tenure going to be on these recreation sites? It isolates future revenue to the province from stumpage.
- As a kayaker, I find these sites are really welcomed. It is a hard haul to get around Douglas Bay. Around the back of Gambier there is no other place to stop.
- Have private landowners in the area been notified?
- Squamish Nation referral

The Natural Resources Advisory Committee had the following comments:

- Who is responsible for maintenance and clean up if the sites are abused?
- The recreation sites initiative is supported in general, although all the locations are not familiar;
- If canoeing and kayaking continue to be popular, as we believe they will, the proximity of Howe Sound to major urban centers will likely result in plenty of use;
- Depending on anchoring bottom, these locations may also be attractive to sailors and power boaters, which may or may not be a problem. Small craft are capable of being lifted easily out of the water don't need anchorage, so they can use campsites that adjoin deep water and rocky bottom;
- Additional concerns include lack of latrines, campfire safety, and the lack of cell phone reception in all of the proposed sites, including Gambier. Relying on marine radios (licensing required) for leisure sea kayakers is folly. SAR boundaries would need to be sorted out, as does a central trip reporting in/out station. Gibsons Harbour may be considered as a suitable reporting location;
- There are no concerns regarding the availability of fresh water. While it would be an asset, it should not be a detriment to a well-prepared voyager;
- One of the sites is close to the proposed mine. There would be concerns on the safety of the kayakers around an industrialized foreshore. This is an interesting point and speaks to the need for an integrated management plan for Howe Sound rather than the piece-meal industrialization that we currently see;
- Strong outflow winds are a rare event, although we often have strong inflow/prevailing winds. Mariners should be prepared and this should not reflect on the designation of the sites;
- Finally, there is the additional concern of the proposed logging on Gambier Island and the affect that would have on the aesthetics of this site.

Please keep the Regional District updated as you move through the process of designating these recreation sites. Our community has lots of interest in the development around West Howe Sound. Please contact me at (604) 885-6804 (ext 5) if you have any questions, or require further information.

4. Business Arising

4.1 Planning and Development Committee Minutes of May 16, Recommendation No. 13 regarding Community Garden/Demonstration Farm at Shirley Macey Park

Director Turnbull reported that the General Manager of Planning and Development had located a diagrammatic plan for a community garden at the Shirley Macey Park site. APC members re-emphasized that they would like the designation of the site "to stay as a 'community garden'".

4.2 Road Map for Agriculture Update

Director Turnbull gave an update on the June 22 APC meeting with two SCRD planners regarding the "Road Map for Agriculture". The Director identified as issues for West Howe Sound the raising of chickens and selling of agricultural goods in the higher density residential areas, and tourist campgrounds in the Agricultural Land Reserve. West Howe Sound was contrasted with Roberts Creek Electoral Area, where population densities are much lower.

Director Turnbull indicated she plans to arrange for another meeting with a planner to enhance the APC's understanding of the impact on Area F of proposed regulations in the Road Map.

Some members expressed confusion about the purpose and goals of the Road Map and of APC involvement in this activity.

5. <u>New Business</u>

5.1 BC Timber Sales (BCTS) 2013 Operational Plans

In addition to the Planner's comment regarding the goshawk, it was noted the APC appreciates this information being forwarded to the APC, and would like to see this continuing.

5.2 Crown Referral for Islet View 1691, Thornborough Channel 169898 and Bain Creek 169900 Recreation Sites along West Howe Sound

Points raised in discussion included:

- My concern is the size of the recreation sites. The smallest one is four hectares. Why do you need so many hectares for people to come in and camp?
- Where are the archaeological sites?
- Think it is a great idea, but it is taking a heck of a lot of land.
- Bain Creek site: concern that reserving the entire part would prevent access to Crown lands beyond, as on either side are steep rock faces.
- Concern about eventually going from being a primitive site to a Class A park. What is the process before it gets from the proposed tenure to a Class A park?
- What is the length of tenure going to be on these recreation sites? It isolates future revenue to the province from stumpage.

- As a kayaker, I find these sites are really welcomed. It is a hard haul to get around Douglas Bay. Around the back of Gambier there is no other place to stop.
- Have private landowners in the area been notified?
- Squamish Nation referral
