**Loghry descendants descended on Bath,** New York, during the weekend of June 7, 2003 and joined local Loghry relatives for a few memorable days of research, touring, and story telling. The activities began on Thursday and wrapped up about noon on Monday, June 9. Those attending the reunion traveled from Texas, Oregon, Alabama, Iowa, New York, and Connecticut. All are descended from various children of Joseph Leander (Land Joe) Loghry and Mary (Santee) Loghry. The Loghry family was in the timber industry, with Joseph settling in the Canisteo Valley with his parents, William Loghry and Nancy (Purdy) Loghry. They came from Pennsylvania in the late 1700s or early 1800s. Later, members of the family became farmers in the area.

Although regional reunions are held throughout the United States, three years ago a meeting was held in Council Bluffs, Iowa with participants from California, Oregon, Alabama, Arkansas, Texas, Connecticut, Illinois, Indiana, Iowa, Oklahoma, and British Columbia, Canada. At that meeting it was decided that we would have another get-together back East in 2003. The next meeting is tentatively planned for Lorain County, Ohio or Illinois in 2006 as we follow the Loghry family's westward trek.

Attending locally, were Gerald and Sylvia Loghry and Gerald's sister Lucille with her husband Joe DeSerio. At the dinner we were joined by Gerald and Sylvia's son, Curt, and his wife Kimberly and their two daughters, Morgan and Megan. The dinner was held at the Tally Ho Restaurant in Kanona, NY, where the owner, Ronny Smith, another Loghry relative, provided an excellent meal that was enjoyed by all. When Ronny was first contacted about the dinner, he asked if the reunion would number in the hundreds since many people from the area could find a tie to the family. Also attending the dinner was George Dickey, another Loghry descendent, and the historian for the Canisteo township. George answered questions after dinner about the Canisteo area and had some interesting background information on the conditions our ancestors endured when they first settled here.

Phil Marsh, from Oregon, acted as host of the event that included a visit to the Steuben County Court House, the Steuben County Historical Society and County Historian's Office. During Friday's research phase we were joined by Shirley Hallett Ahrens, and Jacqueline Hallett MaCauley (more descendents of the Loghry family) from nearby Wellsville, NY, and we certainly appreciated their help and support. Also thanks to the Bath Public Library (is it Dohrman Library?) for their support in letting us use their computers for Internet access and other purposes.

On Saturday, June 7<sup>th</sup>, the Loghry family convoyed to the Oregon School House and met Gerald, Sylvia and Lucille. The "locals" provided us with the history of the Oregon School and how the Oregon Community got its name. After a picture taking session, the family visited local cemeteries, including the Brown's Crossing, Upper and Lower Swale, Burd, and Oak Hill cemeteries. The tour ended at the Buck Settlement Church where the Loghry and Marsh families formerly worshiped.

Those attending from out-of-town were Joe and Doris Loghry from Texas, Jim and Miriam Loghry from Connecticut, Roger and Debbie Jorgenson from Iowa, Erik, Barbara and Azalea Loghry from Newark, NY, Phil Marsh from Oregon (the big Oregon), and Howard and Susan Wolfe from Alabama.

All of the Loghry family wish to thank the helpful and kind citizens of Steuben County for making our stay very pleasant and informative and the many wonderful memories that went home with them. Many of us can still not figure out why any of our ancestors left such a beautiful and hospitable area. **Mrs. James Loghry** - At the home of her son, Charles, Saturday, occurred the death from cancer of Mrs. James Loghry, at the age of 75 years. The funeral was held Monday at the home of her son, Charles Loghry, of Buck Settlement, Rev. S. B. Frazier officiating. Burial was in Nondaga cemetery. Mrs. Loghry's maiden name was Emily Johnson. Her home for many years, and until the death of her husband, was in the town of Cameron. She leaves one son, Charles; three grand daughters; Mrs. Harry Johnson, Mrs. Leo Bebble (?) of Elmira and Miss Marybelle Loghry, of Cameron; a sister, Mrs. Watts, and a brother, Charles Johnson of Cameron. (The deceased was a member of the Methodist Church and her life had been a noble example of its teaching. *(From the local paper dated December 1912 and given to us by Gerald and Sylvia Loghry.*

## Marriage

The bridal march played by Miss Rachel Loghry, sister of the bride, never sounded sweeter than it did in the Wesleyan Methodist church Wednesday evening, January 17 (1900), at 7 o'clock, when the familiar strains announced the arrival of the bridal

party of which Miss Mabel Robinson, as bridesmaid, and Mr. Edward Loghry, best man, led the way up the center aisle, followed by the bride and groom, Miss Margaret Loghry of Bath, and Mr. Frank D. Cochrane of Towlesville, who took their places on a rug in front of the chancel rail directly under an arch of evergreens and white roses from the center of which hung a heart of delicate white roses.

The ceremony was performed by the Rev. I. W. Hill before a church full of relatives and friends, after which the bridal party repaired to the home of the bride next door to the church and took their places in the parlor, where they received congratulations from over a hundred guests.

The bride and bridesmaid wore delicate pink cashmere trimmed with white satin ribbon and lace, white kid gloves and carried bouquets of white carnations. The groom and best man wore the usual black with white kid gloves.

An elaborate supper was served to about a hundred guests, who left many valuable tokens of their esteem for the young couple.

Among friends from abroad were Mr. Longwell and wife from Michigan, uncle of the bride.

In the near future the happy couple will take up their residence in Towlesville, N. Y. *(Given to us in NY by Gerald and Sylvia Loghry.)*

## History

**Santee (210)** - Isaac Santee was born in New Jersey in 1780. His parents shortly removed to Huntington township, Luzerne county, Pa. where they resided in 1790. In 1810 he married Nancy Moore, who was born in 1794, daughter of John and Mary Moore (166). About 1817 they settled at West Cameron, (NY) when Mr. Santee's name first appears on the records of the town, and where their third child, John, was born that year. They settled on the Charles Peck farm, where they afterward remained, his house standing a few rods west of the present residence on that place. He conducted a tavern and was engaged in lumbering, farming and operated a sawmill.

Mr. Santee was prominent in town and church affairs. He was one of the two School Commissioners of Addison township in 1819 and Town Clerk in 1820. He was one of the five delegates from Cameron to the "Anti-rent" convention, held at Bath, Jan. 19, 1830, called "to take into consideration the condition of the settlers in Pultney and Hornby estates." He was the fifth supervisor of Cameron township serving for the year of 1833 to 1836, inclusive. He was Class leader of the regularly organized religious society in town,

which was formed in 1834, at West Cameron.

To Isaac and Nancy Santee were born: Mary (Luther White 263), Lettie (Peter (?) Drake 78-A), John (Rachel Stephens), Joseph (Eliza Sherwood 217-A), William (Amy Williamson 200), James (C. Cole), Jesse (Susanna Williamson 200), and Tamilia (A. Baker).

Mrs. Santee died July 15, 1840, at the age of 46 years. Burial was Brown's crossing burying ground. Isaac married second, Mrs. Nancy (Almy) Owens, widow of Jonathan P. Owens (173). Isaac died Oct. 18, 1864, at the age of 84 years. Burial was beside the remains of his first wife. His second wife died Jan 22, 1863, and is buried beside her first husband in the South Hill burying ground.

Valentine Santee (210-A), father of Isaac, was born in 1740. He was a farmer in Huntington township, Luzerne County, Pa. He married Margaret Funston, and second Mary Craig. He had eight children as follows: Nicolas, William, James, John (J. Moore), Isaac (210), Mary (Joseph Loghry 148-A) Catherine and Nancy.

John Santee (210-B), father of Valentine was a son of Elias. John Santee, or Santer as the name was then spelled, was a Captain of Northumberland Militia, 1777, during the Revolutionary War. His war record in the Penna. Archives Sec. Series page 199, vol. 13. He had besides Valentine one other son named Philemon. Elias had two sons, Isaac and Abraham. *(Also given to us in NY by Gerald and Sylvia. We will have more articles in future editions)*

### **Land holdings of David Wolf(e) (1761-1845)**

David Wolf who lived a large part of his life at Garfield, Maryland with his wife, Nancy Matilda, owned a large tract of land in the area which he arrived at in numerous purchases. The tracts with names are cited in his will dated August 20, 1842. Following is a brief description of some of these holdings and transactions.

1. In 1798 he owned 50 acres called "Brotherly Love" bought in 1792 from Jonathan and Mary Hays.

2. In 1798 he owned "Stoney Batter", a total of 211 acres, believed to have been bought from James Ogle and William Biggs, Jr. in 1793. Ogle and Biggs bought all that tract of land situated and lying in this county aforesaid called "Stoney Batter" (described boundaries and markings) containing one hundred and thirty-nine acres of land together with all the dwelling houses, out houses, orchards, improvements in deed dated 9<sup>th</sup> May, 1791. This was bought from Christopher Westenhavor of Frederick County. Taxes for Wolf's property were

75 pounds.

3. On the 18<sup>th</sup> of Feb. 1808 (WR 32-401) David Wolfe bought "Beiskel's Ridge" from James Warren for 15 pounds. "Beiskel's Ridge" is described as being situated at the end of the first line of "Stoney Batter" granted to Christopher Westenhavor, 27<sup>th</sup> of January 1760. It is believed this transaction of David Wolf's changed the name of the property to "Stoney Batter Enlarged".

4. On the 10<sup>th</sup> of Feb. 1810 (WR 36-331) for \$50.00, David bought from John Hargishimer 2 bay mares, 1 spotted cow, 11 hogs, all household and kitchen furniture.

5. The 1<sup>st</sup> of August 1814 (WR 47-334) for \$100.00 he bought from James and Rachel Burkir "Poplar On the Stone", described as on the south side of a spring branch of the Catoctin Creek on the west side of the Catoctin Mountain, an additional 17½ acres,

6. On the 26<sup>th</sup> of July 1817 (JS 5 394) he sold "Poplar on the Stone" for \$150.00 to John Bussard.

7. On the 25<sup>th</sup> of November 1819 (JS 101) he bought livestock and furniture from Samuel Shipley for \$200.00.

8. On the 25<sup>th</sup> of March 1822 (JS 15, 295) for \$175.00 he sold 10 acres of "Raccoon's Walk" to Daniel Barkman. (Land currently (1997) described as east of Stottlemeyer Road and Southside of Route 77, Foxville area - Source Dorsey Lovel).

9. On the 21<sup>st</sup> of May 1828 (JS 295 20) he bought from Henry Craver for \$48.83 1 black mare and colt, a stove and pipe, iron pots and kettles, furniture and grain.

10. On the 25<sup>th</sup> of August 1830 (JS 34 453) he bought for \$1000.00 from William Biggs, Sr. "Stoney Batter Enlarged" its total of 169 acres.\*

11. On the 6<sup>th</sup> of March 1832 (JS 38 295) for \$508.00 he bought from Yost Wyant part of "Resurvey on Mountain Lot" and part of "Three Mill Seats - 63½ acres.

12. On 1<sup>st</sup> March 1842 (HS 13 295) for \$175.00 he bought from Jacob Ridenour "Poplar Grove" and "The Nest Egg" - 30¾ acres and 27 acres.

#### **Other property owned and not recorded:**

13. "Raccoon's Walk" was a grant to David Wolfe, Sr. - "owed him". The County Surveyor says this was a term commonly used to describe land given for Revolutionary War Service.

14. "Good luck" with addition of 112 acres.

15. 70 Acres of "Ranges Around the Three Miserable Knobs".

16. A small tract running from Moses Hurley's to Wilson Hay's land and part of the "Ranges Around the Three Miserable Knobs".

17. Another tract from the "Ranges Around the Three Miserable Knobs".

18. Acreage from "Ranges Around the Three

Miserable Knobs” given to son Jacob. 19 “Turkey Foot Bottom” and “Valentine Gift” of 213 acres believed to have been owned by David Wolf and sold to John Thomas before 1798.

\*Note: items No. 2 and 3 of “Stoney Batter” with addition of “Beiskel’s Ridge”. What happened to this enlargement and why is this \$1000.00 from William Biggs, Sr. Totaling 169 acres? Is this additional to original 211 acres plus “Beiskel’s Ridge” and then 169 acres more? (*Compiled by Donald Wolfe in 1997 and sent to us by Jeannette Kuhn*)

### 1st National Syrup Tin

Over the last few years our “labor of love” WOLFfe PRINTS project has been a very interesting (sometimes aggravating, sometimes frustrating) task. Overall, it has been a rewarding experience for us because of the people (cousins) we have met both in person and via the Internet and U. S. Postal Service. With that in mind, we have established the 1<sup>st</sup> National Syrup Tin fund. Many of you have sent us donations to cover postage and various expenses since we began our effort. All of your generous contributions have been safely ensconced in a syrup tin. The fund currently contains \$354.67 that is available on a “grant” type basis to anyone who discovers documentation of family history that would be of value to all and making it available to other researchers. This would eliminate duplication of effort. Case in point: while in New York, Jim Loghry and the WOLFfe PRINTS staff visited a community that will remain nameless. Jim asked for information on the Loghry’s and was informed that the Loghry information was researched and given out many times from that office and that somewhere all of that information is available within the family and no further data would be made available. The fund would also be available to someone who may desire to attend genealogy workshops or whatever other reasonable expenditure that may be incurred. Hopefully, a couple of experienced researchers will step forward to help administer the grants. It will be available as long as funds last.
