Medical Consent and Waiver

In consideration of _____ my minor child/ward ("my child"), being allowed to participate in any way in the Forsyth County Bronco football camp, related events and activities, the undersigned acknowledges, appreciates and agrees that:

1. 3. I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child's readiness for participation an/or in the program itself, I will remove my child from the participation and bring such attention of the nearest official immediately; and,
4. I, for myself, my spouse, and on behalf of my/our heirs, assigns, personal representatives and next of kin, hereby release the other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event, with respect to any and all injury, disability, death, or loss or damage to person or property incident to my child's involvement or participation in these programs, whether arising from the negligence of the Releasees or otherwise, to the fullest extent permitted by law.

I, for myself, my spouse, and on behalf of my/our heirs, assigns, personal representatives and next of kin, hereby indemnify and hold harmless all of the above Releasees from any and all liabilities incident to my involvement or participation in these programs, even if arising from their negligence, to the fullest extent permitted by law.
