School-based Assessment (SBA) is a salient feature of the Hong Kong Diploma of Secondary Education (HKDSE) Examination. SBA refers to assessments administered in schools as part of the learning and teaching process with students being assessed by their teachers. Marks awarded will count towards students' results in the HKDSE Examination.

In order to strengthen the message to students about proper conduct in SBA, students are required to sign a declaration form to declare that all SBA tasks/assignments to be completed are their own and to agree to adhere to a code of honour in completing the SBA for all subjects.

If your children have any queries regarding the SBA results, you should encourage them to talk to their teachers and express their views. The school can look into the case according to its stipulated procedures.
