- This application covers the **Summer 2005 terms only**.
- This application is necessary to apply for the following financial aid funds:
 - Federal Pell Grant
 - Federal Supplemental Educational Opportunity Grant (FSEOG)
 - Federal Stafford Loan - Subsidized and/or Unsubsidized
 - Lottery Tuition Assistance (The amount will be determined by the SC Commission on Higher Education.)
 - Federal Work Study

Note: The SC Need-Based Grant and Life Scholarships are not available during the Summer terms.

- In addition to this application, all students must complete the 2004-2005 **Free Application for Federal Student Aid (FAFSA)**. The FAFSA is submitted to the appropriate processing agency, **not MTC**. A mailing envelope is included with each application. You may apply online at <http://www.fafsa.ed.gov/>. Please allow 4-6 weeks from the time you complete and submit your FAFSA, for the **Student Aid Report (SAR)** to be returned to you. By indicating MTC in the **release section Step Six**, we will receive your electronic record around the same time.
- In order for MTC to receive the results of your application, you **must** list MTC as one of your first six college choices in Step Six of the FAFSA. Our **Title IV code number is 003993**. If you do not complete this section accurately, MTC will not receive the results of your application and your application will not be processed.
- For priority consideration, the deadline to turn in your Request for Summer Aid is **April 15, 2005**. A completed application received and reviewed, which meets all federal and institutional requirements by this date, will be considered for the maximum financial aid package available in accordance with institutional, state, and federal guidelines and regulations.
- A completed application is defined as follows: Applications referenced above have been received, reviewed, and found free from error or additional information required has been received by this office.
- Should you receive a request for additional documentation, it is important that you respond as quickly as possible. Funds are very limited during the Summer term; therefore, an award cannot be offered until your file is complete and accurate.
- **Pell Grant** funds are only available to applicants who have not utilized all of their Pell Grant eligibility during the academic year. If you attended full-time during the Fall and Spring semesters, you will not receive any additional entitlement for Pell Grant funds.
- **Lottery Tuition Assistance** will be awarded if funds are available. (You must be enrolled at least six (6) hours).
- **Stafford Loans:** A loan award cannot be given if you borrowed the maximum annual limit during the 2004-2005 academic year. (Annual Stafford Loan Limits: Freshman \$2625; Sophomores \$3500). You must be enrolled at least six (6) hours to remain eligible for loans.
- **Federal Work Study:** You must enroll for at least six (6) hours to be eligible for Federal Work Study consideration.
- **Additional information, including a description of the College's Refund Policy and MTC's Financial Aid Standards of Satisfactory Academic Progress is found in the Student Handbook.**
