- *Basically, make sure the image is not blurry, at least 4"x6" with good resolution, and represents your work well. Remember, the better the image, the better your chances!*

- **Images:** Save your digital image title in the format:

- All artwork must be original; no replications of any published and/or previously produced art allowed. Plagiarized works will be disqualified.
- ***The Committee reserves the right to disqualify work if:***
 - *It is not properly represented by the digital image*
 - *Is suspected to be plagiarized.*

Any artwork that is not emailed according to these specifications will be disqualified.

Deadline: E-Mailed entry submissions must be sent by midnight, August 11th, 2013. Email each entry separately.
