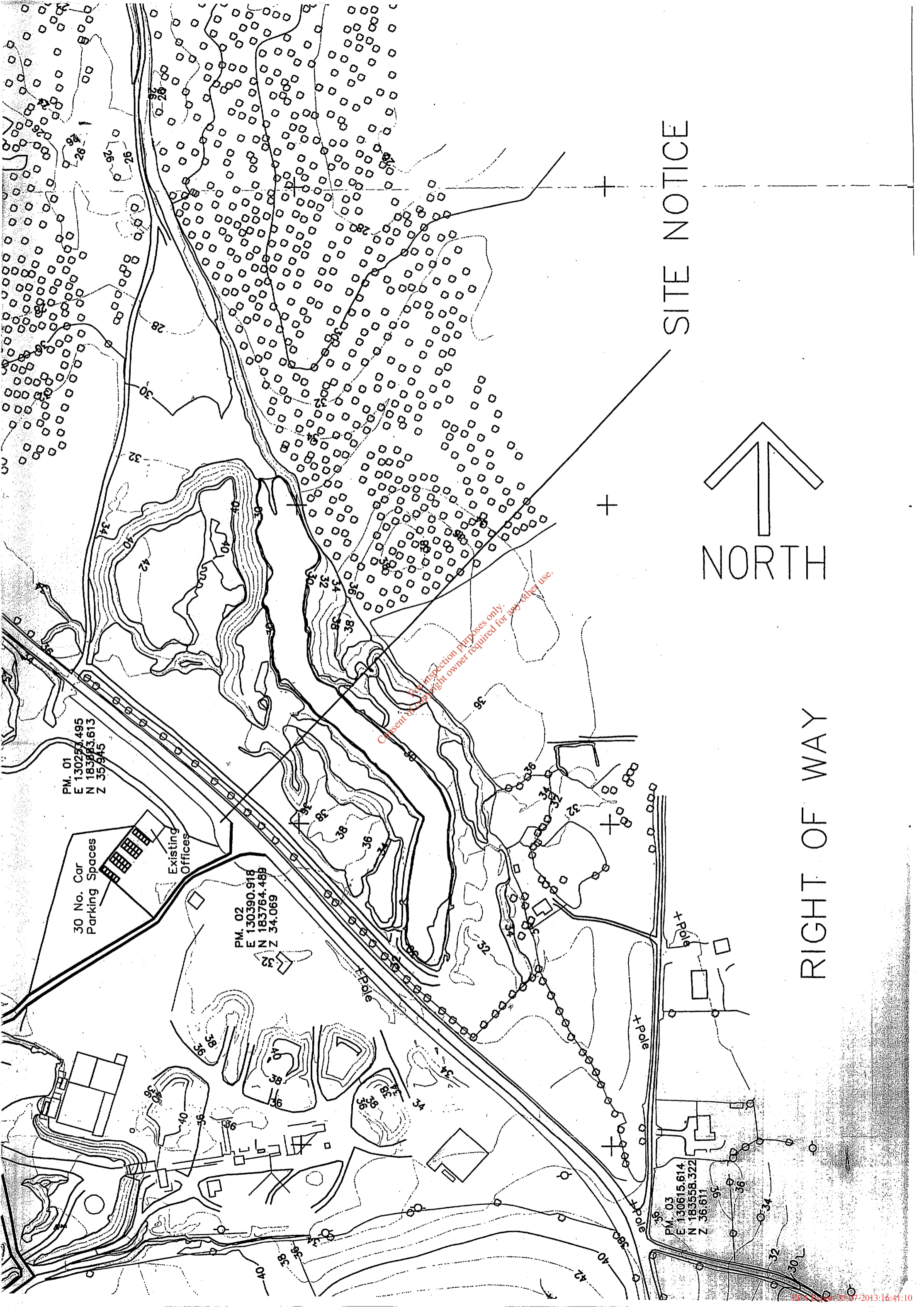

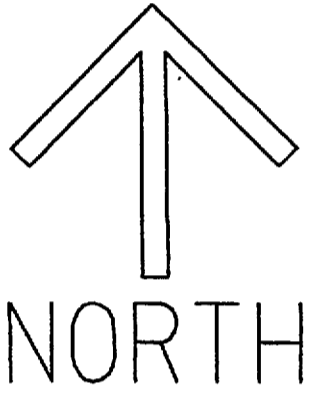



1. Ryans Bros. (Ennis) Ltd., Toonagh Quarry, Ennis, Co. Clare is a wholly owned subsidiary of the CRH Group.
The site location, use of raw materials and the rights to existing access are all granted to Clogrennane Lime Ltd. due to our common ownership and are verified in the attached letter from our Company Secretary.
2. Both Ryan Bros. (Ennis) Ltd. and Clogrennane Lime Ltd. are owned by the CRH Group. The accompanying letters show the letterheads from both companies with their reference to CRH. Please find attached details of both companies from the Companies Registration Office and a letter from the Company Secretary of Ryan Bros. 3. The proposed new development will help to utilise the existing extraction volumes more efficiently and will increase the existing extraction by approx. 15% annually.
