Re: Phone Equipment Loan

This letter is to provide you with important information relating to student participation in our daily scheduled phone lessons and the costs associated.

- 1. **The value of scheduled phone lessons.** In our experience students benefit enormously from daily participation in scheduled lessons for a range of reasons:
 - Direct daily contact with their teacher
 - Direct daily contact with their classmates
 - The opportunity to participate in classroom discussion, debate and group work
 - The opportunity to discuss their learning challenges with peers and their teacher
 - The opportunity to listen to and learn from conversations their peers have with the teachers
 - Establishing and maintaining social skills
 - Establishing and maintaining a sense of belonging to their class and their school.

We therefore strongly recommend that all students actively participate in daily scheduled phone lessons.

2. **To allow your child to participate in scheduled phone lessons**, you need to enter into a loan agreement with the school. You may not use other phone equipment.

Q1 Why can't I use my own speaker phone?

Sorry, but we won't let you do that. The equipment we are using has been specifically designed for our purposes and has features that are unique. You'll only be able to have your child participate in scheduled phone lessons if you choose to use the school provided equipment. Otherwise, the quality and effectiveness of lessons diminishes.

- The phone is a fully duplexed conference phone with a mute button.
- The headset has a PTT (press to talk) and comes with interchangeable and replacement voice tubes, and, because it's a headset, allows the student to have both hands free.
- The phone and headset are designed so that both can operate together, so that the home tutor can fully participate as well as the student.

A refundable cleaning deposit of \$100 must be paid in full before the loan can be processed.

Q2 What if the equipment fails?

The school will accept responsibility unless the damage or fault was as a result of negligence. If you have a problem, you simply need to contact the school technician.

Q3 Can I use the phone for private phone calls?

Yes, but avoid using the headset, because the more you use it, the more voice tubes will need to be replaced and the headset is the really expensive part of the equipment.

Finally, I cannot stress strongly enough the importance and value of a child's participation in regular scheduled phone lessons.
