PETER BAILIE SCHOLARSHIP IN CLINICAL NURSING

GUIDELINES AND APPLICATION FORM

NOTES FOR APPLICANTS

The Peter Bailie Scholarship in Clinical Nursing is intended to assist with the cost of fees and other expenses associated with undertaking postgraduate courses in Clinical Nursing at Flinders University. One or more scholarships to the total value of \$4,000 will be available to be awarded annually to students enrolled on either a full-time or part-time basis. The value of each scholarship will vary depending on the number of scholarships awarded and the level of assistance requested by applicants.

Applicants must normally: (a) be Australian citizens or permanent residents of Australia and residing in South Australia; and (b) have applied for admission to, or be enrolled in, the Master of Clinical Nursing or the Master of Nursing (preference will be given to students intending to enrol, or enrolled, in the Palliative Care stream or the Critical Care stream); and (c) be able to demonstrate that, without financial assistance, they would be unable to undertake, or continue in, the course, or would experience significant financial hardship, and put forward a detailed case for assistance.

The scholarship will be awarded primarily on the basis of demonstrated financial need. Academic merit, as determined by applicants' grade point average in prior tertiary studies, may also be taken into consideration. The selection committee will take into account other forms of assistance available to applicants, in determining financial need. Scholarship recipients may reapply for additional support in subsequent years.

Applications must be lodged with the Higher Degree Administration and Scholarships Office, Registry Annexe, Flinders University, GPO Box 2100, Adelaide SA 5001, Australia by 6 March 2009.

PETER BAILIE SCHOLARSHIP IN CLINICAL NURSING

Preamble

A generous donation from the Trustees of the Estate of the late Peter Bailie, a former Director of Administration and Registrar of the University, has enabled the establishment of the Peter Bailie Scholarship in Clinical Nursing. One or more scholarships to the total value of \$4,000 will be available to be awarded annually. The scholarship is intended to assist recipients with the cost of fees and other expenses associated with undertaking postgraduate courses in Clinical Nursing.

Eligibility

To be eligible for consideration for the award of a scholarship in any given year, applicants must normally:

- (a) be Australian citizens or permanent residents of Australia and residing in South Australia; and
- (b) have applied for admission to, or be enrolled in, the Master of Clinical Nursing or the Master of Nursing (preference will be given to students intending to enrol, or enrolled, in the Palliative Care stream or the Critical Care stream); and
- (c) be able to demonstrate that, without financial assistance, they would be unable to undertake, or continue in, the course, or would experience significant financial hardship, and put forward a detailed case for assistance.

Applications

Applications must be made on the prescribed form, which can be downloaded from the University website, or is available from the Higher Degree Administration and Scholarships Office, and lodged by the specified closing date.

Selection

Selection will be made by a selection committee, comprising the Deputy Vice-Chancellor (Academic), the Dean, School of Nursing and Midwifery, the Course Coordinator: Postgraduate Programs for the School of Nursing and Midwifery and a clinical nurse nominated by the Dean, School of Nursing and Midwifery.

The scholarship will be awarded primarily on the basis of demonstrated financial need.

Academic merit, as determined by the applicants' grade point average in prior tertiary studies, may also be taken into consideration. The selection committee will take into account other forms of assistance available to applicants, in determining financial need. Scholarship recipients may reapply for additional support in subsequent years.

Tenure

One or more scholarships to the total value of \$4,000 will be available to be awarded annually to students enrolled on either a full-time or part-time basis. The value of each scholarship will vary depending on the number of scholarships awarded and the level of assistance requested by applicants. Scholarship holders who withdraw from, or reduce their enrolment in, the course for which the scholarship was awarded may be required to repay to the University part or all of their scholarship.

Source of funds

This scholarship will be funded by a donation from the Trustees of the Estate of the late Peter Bailie. The award will continue as long as donations and earnings thereon are sufficient.
