The validity period of Car/Scooter parking labels, issued by this Ministry for parking vehicles in the premises of government buildings under MHA security cover for the year 2009, will expire on 31-12-2009. Their validity is being temporarily extended up to 15-02-2010.

- 2. New parking labels for the year 2010, will be issued from 20-01-2010 from the Pass Cell located at Jaisalmer House, 26, Man Singh Road, New Delhi. The labels will be affixed on the windscreen of the vehicles by the Pass Cell staff themselves. Government vehicles eligible for issue of MHA car parking label are required to be brought to Jaisalmer House, as per schedule attached, between 10.00 A.M. to 4.30 P.M., for getting the labels affixed. Under no circumstances will the label be handed over to any official or driver of the vehicle.
- 3. Applications in the prescribed proforma i.e. Form A, A-1 or B (whichever is applicable) duly sponsored by the competent authority alongwith an attested copy of the R/C of the vehicle may be submitted to the Section Officer (Pass Cell) by 8-1-2010.
- 4. Ministries/ Departments are requested to circulate these instructions to the Attached/ Subordinate/ PSUs/ Autonomous bodies under their administrative control, also.
