TEAM MATCHES

There will be 2-man and 4-man team cards available for each discipline. Teams **MUST** be named and cards paid for **BEFORE** the first team member fires. All team scores will be paper matches taken from the National Match Course.

Team Fees: 2-man \$5.00, 4-man \$10.00

Lewis System will be used to determine winners. Current NRA rules shall govern and ties will be broken according to NRA procedures. Individual monetary awards will be given for 1st and 2nd places in Classes A, B and C for all matches.

****Two-handed hold permitted, but scores will not be considered for prizes as stated above.
Instead, a separate prize will be awarded for 1st, 2nd and 3rd place from the Grand Aggregate score****

Slots will be given to those entries with the earliest postmarks and total fee remittance. A signed Waiver and Indemnification Agreement must be on file prior to participation. Safety flags are required.

The Franklin R&R Association reserves the right to cancel any of the matches comprising the program or to make changes or eliminations relative to this program, prior to or during the match providing any unforeseen condition compels such action.

NO ALIBIS except when a competitor has fired on another's target. The competitor with less than the prescribed number of hits on their target must accept the missing hits as misses. The competitor with more than the prescribed number of hits has the option of a re-fire or acceptance of a score equal to the required number of hits of the lowest value.

CHALLENGES: A challenge must be made immediately upon announcement of score by the scorer. No challenge will be accepted after the target has been posted or replaced. A challenge fee of \$1.00 will be charged to all competitors making challenges and is payable before making the first re-check of the challenged score.

Special Events Waiver and Indemnification Agreement

In return for convenience in firearms usage, training, use of Premises, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned signatory to this Agreement (the "**Undersigned**"), for himself/herself and all his/her heirs, assigns and beneficiaries, agrees to the following:

The Undersigned, for himself/herself and his/her heirs, assigns and beneficiaries agrees to indemnify, hold harmless and defend the **Franklin Revolver and Rifle Association, Inc.**, and all of its employees, directors, officers or agents (collectively the "**FR&R**"), from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits the Undersigned may assert against FR&R arising out of, related to or connected with: (i) the discharge of firearms; and, (ii) any course of instruction (from whomever conducted); and, (iii) the FR&R range, buildings, land, parking area, facilities and premises (the "Premises"), including the Undersigned's presence and/or use of said Premises. Should any such claim, demand or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of the United States, the State of New Jersey, or under any theory of law or equity, the Undersigned will indemnify, hold harmless and defend the FR&R, from any and all costs, expenses or liability including, but not limited to, the cost of any settlement or judgment made or rendered against the FR&R, whether individually, or severally or jointly with the Undersigned, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand or lawsuit, including attorney's fees.

The Undersigned furthermore waives for itself and its executors, administrators, assignees or successors, any and all rights and claims for damages, losses, demands and any other actions whatsoever, which it may have or which may arise against the FR&R, (including but not limited to claims related to injuries, damages or illnesses suffered by the Undersigned or the Undersigned's property), which may, in any way whatsoever, arise out of, be related to or be connected with: any course of instruction; the Premises, including any latent defect in the Premises; the Undersigned's presence on or use of said Premises; the Undersigned's property (whether or not entrusted to the FR&R; and, any discharge of firearms. The FR&R shall not be liable for, and the Undersigned, on behalf of itself and its executors, administrators, assignees or successors hereby expressly releases the FR&R from, any and all such claims.

The Undersigned hereby expressly assumes the risk of entering the Premises and of taking part in activities on the Premises which include, but are not limited to, the discharge of firearms and the firing of live ammunition.

The Undersigned furthermore hereby acknowledges and agrees that he or she has read, understands and will at all times abide by all FR&R Range Rules and procedures.

The Undersigned agrees that if he or she causes or contributes to damage to Franklin R&R property the Undersigned will be responsible for all costs associated with the repair or replacement of the property so damaged.
