STEP 4. Please read the following release waiver and sign at the bottom.

General Waiver & Release - Important Information

The Deerfield Park District is committed to conducting its recreation programs and activities in a safe manner and holds the safety of participants in high regard. The Deerfield Park District continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participants safety. However, participants and parents/guardians of minors registering for this program/activity must recognize that there is an inherent risk of injury when choosing to participate in recreational activities. You are solely responsible for determining if you or your minor child/ward are physically fit and/or skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way, or recently suffered an illness, injury, or impairment, to consult a physician before undertaking any physical activity.

Warning of Risk

Despite careful and proper preparation, instruction, medical advice, conditioning, and equipment, there is still a risk of serious injury when participating in any activity/program. Understandably, not all hazards and dangers can be foreseen. Participants must understand that certain risks, dangers, and injuries due to acts of God, inclement weather, slipping, falling, equipment failure, in supervision, premises defects, and all other circumstances inherent to recreational activities/programs exist. In this regard, it must be recognized that it is impossible for the Deerfield Park District to guarantee absolute safety.

Waiver & Release of all Claims and Assumption of Risk

Please read this form carefully and be aware that in signing up and participating in this program/activity, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages, or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected and associated with this program/activity (including transportation services, when provided). I recognize and acknowledge that there are certain risks of physical injury to participants in this program/activity, and I voluntarily agree to assume the full risk of any and all injuries, damages, or loss, regardless of severity, that my minor child/ward or I may sustain as a result of participation. In the event of an emergency, I authorize District officials to secure from any licensed hospital physician, and/or medical personnel any treatment deemed necessary for me or my minor child's/ward's immediate care and I agree that I will be responsible for payment of any and all medical services required. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this program/activity against the Deerfield Park District, including its officials, agents, volunteers, and employees (herein after collectively referred to as Deerfield Park District"). I do hereby fully release and forever discharge the Deerfield Park District from any and all claims for injuries, damages, or loss that my minor child/ward or I may have which may accrue to me or my minor child/ward and arising out of, connected or in any way associated with this program/activity. I have read and fully understand the above important information, warning of risk, assumption of risk and waiver and release of all claims. STEP 5. Please read the following refund policy.

Refund policy for Coho Swim Club

1. A refund of DFPD program fees may be obtained prior to the first practice of a Coho season. A 10% service charge (\$5 Minimum/\$10 Maximum) will be deducted from the amount paid for the season.
2. Once a Coho season begins, and prior to it ending, you may request a prorated refund of DFPD program fees based on the number of weeks attended and the date the refund request is received. A 10% service charge (\$5 Minimum/\$10 Maximum) will be assessed.
3. Refunds will not be processed for a Coho season once it has ended.
4. The ISI/USA Swimming Registration Fee and Coho Activity Fee will not be refunded once a Coho season has begun. In addition, refunds will not be given for any equipment or apparel that has been ordered.
5. Refunds will be offered if the program is cancelled or closed by the park district.
6. If a participant is dropped from the program at the request and discretion of the district staff, a refund will be made, less the prorated cost of weeks passed.
7. In lieu of a refund, participants may transfer money to other currently offered activities. The amount to be transferred will be prorated based on the number of weeks of the current Coho season that have already passed.
