- This dog is sold as a pet. Pet quality simply refers to the dog being sold as a pet and companion only.
- This dog is not being sold under co-ownership terms. Payment in full must be made prior to you taking ownership of the dog; payment is in cash or money order.
- Breeder guarantees that the above dog is a purebred and registered with the American Kennel Club (AKC)
- Breeder cannot guarantee adult size, color, hair coat, eye colors, temperament or training ability of puppy.
- Breeder does not assume any liability for any injury, or neglect to puppy after deliver.

Health Guarantee:

The seller certifies that, upon receipt, the dog is in good health and has been immunized and worme	∍d
according to the accompanying heath records. This dog has the following conditions

Conditions listed above are excluded from any guarantee and is not valid to reject the puppy due to these conditions.

The buyer agrees to have the dog examined by your veterinarian at buyers' expense within 3 days from date of purchase. If said dog is not examined by a licensed veterinarian within 3 days of delivery all guarantees listed below are void. If the veterinarian does not give the dog a clean bill of health, buyer must notify the seller immediately. Seller reserves the right to have the dog re-examined by our veterinarian at our cost. Seller will not accept responsibility for any harm that comes to the dog once in your possession such as accidents, electrocution, heat related conditions or any other related

actions. Seller does not accept responsibility for contagious diseases diagnosed after 3 days from the date of possession.

If the dog is found to have a serious physical condition other than but not limited to, the presence of common parasites (mites, round-worms, coccidia, Giardia, hookworms, etc.) a viral or bacterial cold or bacterial infection, which is easily treated, fleas, small scratches, scrapes or bites from other puppies or coughs that are deemed to be short-term the breeder, Seller will resume possession if this is agreeable to both parties and the seller will replace the puppy with another puppy as soon as one is available of the same sex and value. Replacement of the dog with one of the same sex and value from the next available litter bred by the Seller if the genetic condition is sufficiently serious in the opinion of two qualified veterinarians, at least one of whom is selected by the Seller, to warrant euthanization of the dog.

Hip and elbow dysplasia is covered for 1 year from date of purchase with the same conditions as above in effect. Your dog has been tested and examined for many conditions to assure his health. Heat stroke, exhaustion, dehydration and other heat related conditions are not covered in any way. Remember that a Siberian husky can over heat quickly and easily and may die as a result of overheating. NO CASH REFUNDS AND REPLACEMENTS ONLY. At no time will the seller be responsible for any vet fees incurred.

The Buyer's Responsibility:

The Buyer agrees to take good care of this dog, feed and house the dog properly, maintain shots, control the dog on a harness or leash when in public and when off the premises of the dog's home. The dog's outdoor area will be fenced in and secured, or acceptable provisions will be made to assure the dog is safe any time he/she is outdoors. Buyer agrees to give the dog proper physical and emotional care and welfare. If the dog is found to be allowed to run freely, running at large, creating a public nuisance, or found to be neglected, abused or allowed to live in poor health or poor conditions the Seller has all rights to repossession of this dog with no refund to the buyer. The death, injury or loss of said dog due to theft, carelessness, recklessness, abuse, neglect, heat stroke or accident will not entitle the buyer to any compensation from the seller.

This dog is warranted only for the purpose of being a companion animal, not for any other purpose or reasons. No warranty is given to the buyer for any special purpose or function of this dog. This dog is not to be used for any illegal or immoral activities and is not to be used for any type of dog fighting, puppy mill, dog farm or other mass producing or money making operation.

This dog is sold with AKC registration (unless otherwise noted).

This dog is to be spayed or neutered if purchased with Limited registration. Upon receiving proof of spayed/neutered provided by a veterinarian a refund of \$50 will be provided to the buyer.

In the event the buyer is unable to keep this dog for any reason, the Buyer agrees to offer to the Seller the first chance to take this dog back. In the event of a re-sale the Buyer must notify the Seller with the new name and address of the new buyer and it must be approved by us first.

Buyer agrees not to sell this dog to any retail company or establishment. Any changes to this contract must be in writing and signed by both parties. This contract is legal and may be enforced by legal means at the buyers' expense and all disputes must be settled in the state of Virginia. This dog is sold to you as a pet only and nothing further.
