BID GUARANTEE:	Each bid shall be accompanied by a bid bond, certified check, cashiers check, bank check or money order (not a personal check or company check) in the amount of 10% bid price, payable to the School District of Mercer as a guarantee that if the bid is accepted, the bidder will execute and file the proper contract and bonds with the time set by the Owner or the bid guarantee will be forfeited.
METHOD OF SUBMISSION:	U.S. Mail, Hired Carrier Delivery or in-person. Fax bids will not be accepted.

PERFORMANCE & PAYMENT BONDS:	100% of contract price
PAYMENT:	100% will be retained until the work is complete and deemed acceptable to the Owner as to compliance to the specifications, as mutually agreed upon, by the Owner and the Contractor for the project.
STANDBY LETTER OF CREDIT:	
total	The successful bidder will provide the owner with a Standby Letter of Credit (LOC) in the amount of 10% of contract value for the first year of the time period of the warranty as agreed upon. The Letter of Credit will decline to 5% for the second year of the same warranty period if no draw on the LOC has occurred during the first year. This Letter of Credit shall be established with a reputable US Financial institution. The terms specific for the LOC will be mutually agreed upon by both the Owner and the successful bidder and established with the appropriate paperwork indicating proof of the LOC existence, and submitted to the Owner prior to commencement of any project activities being initiated.
BIDDER'S QUALIFICATIONS:	Only qualified General Contractors may submit bids on the project work. The Owner reserves the right to reject any and all bids, to waiver any informalities in bidding, and to accept any bid deemed in the best interest of the Owner.
	All bids remain subject to acceptance for thirty (30) days after the bid opening date, and the Owner may, in its sole discretion, release any bid and return it prior to that date.

HOURS OF WORK: SCHEDULE DELAYS	Work to be performed during normal business hours Beginning July 6th, 2015. The project must be completed no later than August 21st, 2015. For each day the project is delayed (Not caused by the Owner) which is beyond the completion date of August 21 st , 2015 a 1% penalty (of contract value) shall be assessed. This penalty is capped at a maximum of 20% of the contract value and may be deducted from final payment.

SCOPE OF PROJECT

Bid: Remove and dispose of approximately 31,765 sq. ft. of existing Duralast roofing and insulation.

Replace with high grade, energy efficient insulation at appropriate locations (interior and exterior applications). All proposals should meet ASHRAE 90.1 2010 or later.

Install approximately 31,765 sq. ft. of roofing with appropriate leak proof seals, flashings and trim around all vents, drains, equipment, piping etc.

Install additional appropriate drainage where needed.

Replace roof vents with new fixtures.

Install finish trim and fascia to match building exterior.

All acceptable bids must include a comprehensive warranty of no less than twenty (20) years.

Preference will be given to local contractors when costs are not prohibitive.

Contractor will be responsible to remove from site and dispose of properly the removed roofing and insulation materials, construction waste and packaging materials. All work to be completed in a workmanlike manner according to standard practices. Any alteration or deviation from above specifications involving extra costs will be executed only upon written orders.
