The School of Economics at The University of Queensland is offering one postgraduate coursework scholarship covering up to 100 percent of tuition fees for an Aboriginal or Torres Strait Islander student. The scholarship will be awarded to a student who is seeking admission into one of the following School of Economics coursework master programs:

- Master of Business Economics
- Master of Development Economics
- Master of Economics and Public Policy
- Master of Health Economics
- Master of International Economics and Finance

Eligibility

This scholarship is only open to persons who are Australian Aboriginal or Torres Strait Islander. A Certificate of Aboriginality will need to be included in your application. Prior study of economics is not required.

Basis of award

The scholarship is awarded on the basis of undergraduate academic results and relevant work experience. Applicants may be required to attend an interview.

Application procedure

1. Fill in the application form on the next page, and attach your Certificate of Aboriginality
2. Attach a covering letter to your application outlining why you wish to study a postgraduate program with the School of Economics, and a brief summary of your work history and how this program will benefit you. You may also wish to include a personal statement of other interests and achievements that you consider relevant to the scholarship selection committee
3. Submit your application by the closing date (see page 3 below).
