1.0 Description

This is a service contract for the Embassy Djibouti's *installation of hand held bidet sprayer in all toilets* to the U.S. Embassy Djibouti, as described in this solicitation. The contract type is a requirements type contract for *installation of hand held bidet sprayer in all toilets*. All proposal packages must be accomplished with a work plan and projected site visit dates for all listed tasks within this work statement.

2.0 SCOPE OF WORK STATEMENT

INTRODUCTION/BACKGROUND

This is a Firm Fixed Price Contract for On-site Services at the US Embassy in Djibouti, Djibouti. The U.S. Embassy, Djibouti has recently approved the installation/redesign of its toilets to enhance better health standards for all embassy personnel by installing hand held bidet sprayers. The toilets in the embassy were built without bidet sprayers and the Locally Employed Staff (LES) has begun using large plastic bottles for the purpose cleaning their genital and rectal areas. These bottles are used over and over by personnel then left throughout the toilets causing a health hazard. In [Muslim countries](#), where bidets are used, they are often a small hose with a nozzle, similar to a sink sprayer. The sprayer-type bidets are sold to Muslims as "Shataf," which permit the user to comply with [Islamic Laws about using the toilet](#) and the cultural preference of using water instead of paper.

SCOPE OF WORK (SOW)

The intent of this service work is the installation of **Hand Held Bidet Sprayer's** to all toilets including installation and testing of hand held bidet sprayer located throughout the U.S. Embassy, Djibouti. The selected contractor will be responsible for the installation, testing, cleanup and required follow-up repairs in order for the system to be fully functional as per the contract of the newly installed Bidets based on feedback to be provided by Facility Manager (FM). Each stage of the project will require approval from FM before moving on to the next stage. The selected contractor must ensure he has adequate trained resources for installation and testing of the newly installed equipment. Specific deliverables and milestones will be listed in the Work Requirements, and Schedules/Milestones sections of this SOW.

PERIOD OF PERFORMANCE

The period of performance for the installation of hand held bidet sprayers is 60 days beginning on 25 March 2013 through 25 May 2013. All works must be scheduled to be

completed within this timeframe. Any modifications or extensions will be requested through FM and Contractors Contracting Officers (COs) for review and discussion.

PLACE OF PERFORMANCE

The selected contractor for the toilet bidet project will perform 100% of the work at the U.S. Embassy, Djibouti. The contractor will be required to meet with FM once a week (day and time) to be announced (TBA) for a Weekly Status Meeting. Additionally, all project reviews will be held at Embassy Facility and attended by the Contractor. FM will provide and arrange for meeting spaces within its facility for all required Contractor meetings.

WORK REQUIREMENTS

As part of the project, the contractor will be responsible for performing tasks throughout various stages of this project. The following is a list of those tasks which will result in the successful completion of this project:

1. Contractor will create and present detailed Project Plan (PP) including schedule, installation, testing, clean-up and handoff.
2. Contractor will present the PP to FM for review and approval.

Design Phase:

- Works with FM to gather requirements and establish metrics
- Creates design based on collected requirements
- Presents written status at Weekly Meeting

Build Phase:

- Complies with all codes for approved site design
- Provides FM with a detailed testing plan
- Includes all content provided by FM on redesigned toilets
- Resolves any code and site issues identified in testing
- Compiles a Testing Report to present to FM for review/approval
- Transports all materials to be disposed of from the point of removal to designated Disposal Storage Site, and shall ensure that all items removed through this work is properly disposed
- Directs all of those under his charge to work safely. Regular safety meeting shall be held among on-site contractor personnel, and safety concerns shall be brought to the attention of the Post Safety and Health Officer (POSHO)

Project Handoff/Closure:

- Provides FM with all documentation in accordance with the approved Project Plan
- Presents Project Closure Report (PCR) to FM for review and approval
- Completes the Project Requirements Checklist (PTC) showing that all project tasks have been completed
- Guarantees a 90 day warranty of labor and parts
- Presents written status at Weekly Meeting

ACCEPTANCE CRITERIA

For the toilet bidet project, the acceptance of all deliverables will reside with FM's Deputy Facility Manager (DFM). The DFM will ensure the completeness of each stage of the project and that the SOW has been met. Once a project phase is completed and the contractor provides their report/presentation for review and approval, the DFM will either sign-off on the approval for the next phase to begin, or reply to the contractor in writing, advising what tasks must still be accomplished.

Once all project tasks have been completed, the project will enter the Handoff/Closure stage. During this stage of the project, the contractor will provide their PCR and PTC to Embassy DFM. The acceptance of this documentation by embassy DFM will acknowledge acceptance of all project deliverables and that the contractor has met all assigned tasks.

Any discrepancies involving completion of project tasks or disagreement between embassy and the chosen contractor will be referred to both organizations' COs for review and discussion.

OTHER REQUIREMENTS

All contractor project team members will submit security forms to Embassy for clearance and access badges to the facility. Contractor will be escorted whenever necessary.

All testing will be done at the US Embassy. Any water outages will be scheduled for the installation build phase of this project. Prior to water outages, all sections will be notified will.

SECTION 5 - REPRESENTATIONS AND CERTIFICATIONS

- 52.212-3 Offeror Representations and Certifications—Commercial Items (APR 2012).

An offeror shall complete only paragraph (b) of this provision if the offeror has completed the annual representations and certifications electronically via <https://www.acquisition.gov>. An inverted domestic corporation as herein defined does not meet the definition of an inverted domestic corporation as defined by the Internal Revenue Code at [26 U.S.C. 7874](#).

“Manufactured end product” means any end product in Federal Supply Classes (FSC) 1000-9999, except—

- (1) FSC 5510, Lumber and Related Basic Wood Materials;
- (2) Federal Supply Group (FSG) 87, Agricultural Supplies;
- (3) FSG 88, Live Animals;
- (4) FSG 89, Food and Related Consumables;
- (5) FSC 9410, Crude Grades of Plant Materials;
- (6) FSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) FSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) FSC 9610, Ores;
- (9) FSC 9620, Minerals, Natural and Synthetic; and
- (10) FSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

(2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;

(3) Consist of providing goods or services to marginalized populations of Sudan;

(4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;

(5) Consist of providing goods or services that are used only to promote health or education;

or

(6) Have been voluntarily suspended.

“Sensitive technology”—

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act ([50 U.S.C. 1702\(b\)\(3\)](#)).

“Service-disabled veteran-owned small business concern”—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in [38 U.S.C. 101\(2\)](#), with a disability that is service-connected, as defined in [38 U.S.C. 101\(16\)](#).

“Small business concern” means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government

contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

“Subsidiary” means an entity in which more than 50 percent of the entity is owned—

- (1) Directly by a parent corporation; or
- (2) Through another subsidiary of a parent corporation.

“Women-owned small business concern” means a small business concern—

(1) That is at least 51 percent owned by one or more women; or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; and

(2) Whose management and daily business operations are controlled by one or more women.

“Women-owned small business (WOSB) concern eligible under the WOSB Program” (in accordance with 13 CFR part 127), means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States.

In the course of the hearing, the taxpayer is entitled to contest the underlying tax liability because the taxpayer has had no prior opportunity to contest the liability. 652.225-70 ARAB LEAGUE BOYCOTT OF ISRAEL (AUG 1999)

(a) Definitions. As used in this provision:

Foreign person means any person other than a United States person as defined below.

United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
