2	Digitally Typed and Printed State Department DS-82 Passport Application (PART 2 on our website) - This online application can also be found here - https://pptform.state.gov/ (handwritten form NOT acceptable) - Go Past the privacy disclaimer – and on the next page click SUBMIT under "Apply Online" - Enter all passport information requested by the State Department – red asterisk fields required - "Summary of Fees" page (only check \$60 Expedite at Agency Fee & \$110 Passport Book Fee) click SUBMIT - "Next Steps" Page – Scroll to the bottom of the page and click CREATE FORM - Your completed Passport Application form will open as a PDF document, PRINT IT OUT				
3	Two Recent Passport Photos - Go to your local Kinko's, CVS, or Photo Shop (Do not staple your photos to the form) (no glasses or head wear)
