PASSPORT RENEWAL CHECKLIST:

1	<p>United States Passport</p> <ul style="list-style-type: none"> - Your passport must have been valid for 10 years and have expired within the last 5 years to be renewed - You may renew a still valid 10 year passport - Child passports are only valid for 5 years and therefore cannot be renewed - If your name has changed you also must provide a marriage certificate, divorce decree, or court document - Your passport must be in good condition
2	<p>Digitally Typed and Printed State Department DS-82 Passport Application (PART 2 on our website)</p> <ul style="list-style-type: none"> - This online application can also be found here - https://pptform.state.gov/ (handwritten form NOT acceptable) - Go Past the privacy disclaimer – and on the next page click SUBMIT under “Apply Online” - Enter all passport information requested by the State Department – red asterisk fields required - “Summary of Fees” page (only check \$60 Expedite at Agency Fee & \$110 Passport Book Fee) click SUBMIT - “Next Steps” Page – Scroll to the bottom of the page and click CREATE FORM - Your completed Passport Application form will open as a PDF document, PRINT IT OUT
3	<p>Two Recent Passport Photos</p> <ul style="list-style-type: none"> - Go to your local Kinko's, CVS, or Photo Shop (Do not staple your photos to the form) (no glasses or head wear)
4	<p>Proof of Travel Departure (I include one of the following)</p> <ul style="list-style-type: none"> - One clear photocopy of an Airline Plane Ticket Confirmation with your name as the passenger - If driving across the border include a copy of a foreign hotel reservation with your name as the guest - If traveling for business you may type a company letter (see sample) www.urgentpassport.com/cloe/
5	<p>Photocopy of Identification (I include one of the following)</p> <ul style="list-style-type: none"> - One clear photocopy of your valid state issued Driver's License, State ID Card, or Military ID
6	<p>Government Fee of \$170.00</p> <ul style="list-style-type: none"> - Passport Fee must be paid with a <u>Personal Check</u> or <u>Money Order</u> payable to “US Department of State” - Write your date of birth in the memo portion of your check or money order - Check or money order must be clear - Name & Address must be on check - Scratch outs or post dates get rejected - If also applying for a passport card add \$30.00 to the government fee (cards take 30 days to process)
7	<p>Urgent Passport Letter of Authorization</p> <ul style="list-style-type: none"> - This form is included in this PDF document - please complete by hand with blue or black ink - We recommend only checking the first 2 boxes for best service / Courier Company Name is "Urgent Passport"
8	<p>Urgent Passport Order Form & Expediting Fee</p> <ul style="list-style-type: none"> - The order form is included in this PDF document - can be completed by hand or typed in - Please fill this form out completely - including expediting service, payment info, and shipping info
