Publication series included in this subscription:

TR News	Bimonthly. Contains discussions of the activities and programs of the Board and transportation activities of government and industry in the United States and other countries, feature articles on timely subjects, and publishes announcements of TRB publications and meetings. Includes the TRB Annual Report, which summarizes TRB activities and includes a financial statement.
Transportation Research Record	Irregular. Each Record contains several technical papers on a given subject. The papers are usually prepared for a TRB Annual Meeting and accepted for publication through TRB's technical review process. These papers have relatively permanent significance. Approximately 50 are released annually.
Special Report	Irregular. Most Special Reports are the result of Congressionally mandated policy studies on timely topics. Approximately 3-5 are issued annually.
Conference Proceedings	Irregular. These are the proceedings of and research prepared for conferences and workshops held by TRB on a wide variety of transportation issues. Approximately 1-2 are issued annually.
NCHRP Report	Irregular. Each contains the final report of research conducted under the National Cooperative Highway Research Program, which is administered by the Board for State Highway and Transportation Departments and the Federal Highway Administration. Approximately 20 are issued annually.
NCHRP Synthesis of Highway Practice	Irregular. Synthesizes existing information on selected topics and points the way toward recommended practices. Approximately 10 are issued annually.
NCHRP Research Results Digest	Irregular. Issued as warranted to provide early awareness of research results emanating from NCHRP projects before the final reports are published. Approximately 8-10 are issued annually.

NCHRP Legal Research Digest	Irregular. Issued to provide early awareness and encourage application of research results emanating from NCHRP Project 20-6, Legal Problems Arising Out of Highway Programs. Approximately 1 is issued annually.
NCHRP Summary of Progress TCRP Report	Annual. Provides a detailed overview of the NCHRP projects open during the year reviewed. Irregular. Each contains the final report of research conducted under the Transit Cooperative Research Program, which is administered by the American Public Transit Association and the Federal Transit Administration. Approximately 10–15 are issued annually.
TCRP Synthesis of Transit Practice	Irregular. Synthesizes existing information on selected topics and points the way toward recommended practices. Approximately 3–5 are issued annually.
TCRP Research Results Digest	Irregular. Issued as warranted to provide early awareness of research results emanating from TCRP projects before the final reports are published. Approximately 5 are issued annually.
TCRP Legal Research Digest	Irregular. Issued to provide early awareness and encourage application of research results emanating from TCRP Project J-5, Legal Problems Arising Out of Transit Programs. Approximately 1 is issued annually.
TCRP Annual Report	Annual. Provides a detailed overview of the ongoing TCRP projects during the year reviewed.
Commercial Truck and Bus Safety Synthesis Program	Irregular. A new series sponsored by the Federal Motor Carrier Safety Administration dedicated to commercial truck and bus carrier safety. Approximately 4 are issued annually.
ACRP Synthesis of Airport Practice	Irregular. Synthesizes existing information on selected topics and points the way toward recommended practices. Approximately 5 are issued annually.
ACRP Report	Irregular. Each contains the final report of research conducted under the Airport Cooperative Research Program, which is administered by the Federal Aviation Administration. Approximately 8 are issued annually.
ACRP Research Results Digest	Irregular. Issued as warranted to provide early awareness of research results emanating from ACRP projects before the final reports are published. Approximately 2-4 are issued annually.
SHRP 2 Reports	Irregular. Each contains the final report of research conducted under the SHRP 2 program, which is administered by TRB in cooperation with the Federal Highway Administration and the American Association of State Highway and Transportation Officials. Approximately 4 are issued annually.
