1.	Space Agreement.	
	A. KCC hereby offers space number at the KCC outrigger canoe storage ("Hale") to the above noted Member.	hale
2.	Term of Rental.	

This Agreement is for the period of January 1, 2016 to December 31, 2016.

3. <u>Yearly Rental Fee</u>.

A.

- A. The rental fee for a single OC-1 storage space is Two Hundred and no/100 Dollars (\$200.00 U.S.)
- B. The rental fee for a single OC-2 storage space is Two Hundred Fifty and no/100 Dollars (\$250.00 U.S.)
- C. The rental fees listed above include use of the wash racks, water and a key for entry. Replacement of any key will incur a charge of \$25.00.
- D. Rental fees are due on or before January 1, 2016.

4. Conditions of Rental/Prohibited Activities.

- A. Each Member shall be a Member in good standing of KCC at the time this contract is entered into and shall pay membership dues on or before January 1, 2016. If membership fees are not paid by February 1, 2016 it will result in forfeiture of your rental fee payment and removal of the canoe and accessories from the Hale. Reinstatement to the <u>wait list</u> will be upon written request.
- B. KCC is not responsible for any loss or damage that may occur to the canoe, its attachments or accessories, while stored at the KCC Hale.
- C. KCC does not maintain property, liability, or hull insurance on the canoes and Members are encouraged to get their own insurance.
- D. In the event a Member changes clubs for anything other than participation in the HCRA/MCHCA distance season, they will be deemed to be a member of the club to which they have transferred and will forfeit their rental fee payment and Hale space.

- 7. <u>Rules and Regulations</u>. All rules, regulations and guidelines adopted by KCC for the use of the Hale shall be observed by the Member. Failure to abide by any rule, regulation or guideline, or any portion of this Agreement can result in termination of this Agreement immediately by KCC.
- 8. <u>Wait Lists</u>. KCC maintains a waitlist of Members desiring to obtain a space in the Hale. Spaces will be offered to fulltime Maui residents who are Members in good standing with KCC as spaces become available and in accordance with the order in which a Member appears on the waitlist. If a Member refuses an offered space, the Member will maintain their position on the waitlist and the space will be offered to the next Member appearing on the waitlist.

In the event spaces are available and no additional Members are on the waitlist, spaces may be offered to non-members for a fee to be determined by the KCC Board of Directors.

9. <u>Non-Assignability/No Subletting</u>. There shall be no assignments or subletting under this Agreement. In the event a Member with a Hale space sells their canoe to a new owner, the Hale space will be forfeited along with the rental fee and will then be offered to those Members on the waitlist. If a Member with a Hale space does not have a canoe, the Hale space must remain empty.

Failure to have a canoe in the Hale space for more than six months will result in forfeiture of the space to KCC and the space will be offered to a Member on the waitlist.

10. <u>No Waiver</u>. Failure of KCC to insist upon strict compliance with any of the terms, covenants and conditions of this Agreement shall not be deemed a waiver of such terms, covenants and conditions, nor shall any waiver or relinquishment of any right or power hereunder at any one or more times be deemed a waiver or relinquishment of such right or power at any other time or times.
