RULES AND REGULATIONS FOR 2014

- “The \$20,000 Magic Valley Weight Loss Challenge” is a weight loss competition that will award the top 15 individuals who lose the highest *percentage of body weight. (Two other prizes are reserved for participation and family event).
- Registration forms will be available at the kickoff event on Saturday, January 4th or at any of these sponsors’ locations: any Twin Falls YMCA or Kurt’s Pharmacy and Hallmark
- The competition kicks-off **Saturday, January 4th** and initial weigh-ins take place from **11am – 1pm** at the Magic Valley YMCA at **1751 Elizabeth Blvd**, Twin Falls. Participants who cannot attend the kick-off have until **Saturday, January 11th at 5pm** to weigh-in at Kurt’s Pharmacy at **1203 Filer Ave E**, Twin Falls or any YMCA Location.
- The deadline for all contestants to qualify for the cash prizes in the \$20,000 Magic Valley Weight Loss Challenge is Saturday, January 11th at 5pm. At this time all contestants must have submitted completed registration form, provided valid ID, paid the \$95.00 registration fee, and weighed in.
- After the initial weigh-in, participants must weigh in **ONCE A MONTH** at **Kurt’s Pharmacy** or any **YMCA Magic Valley Weight Loss “Lose It!” or Goal Setting Workshop** to stay eligible for prizes.** (February, March, April, May, and Finale in June).
- Teams are encouraged for the 2014 competition.
- ***Everyone must furnish an official, current, state-issued ID at their first and last weigh-ins.
- Participants **MUST** wear shorts and T-shirt for first and last weigh ins. Socks may be worn. Shoes may **NOT** be worn.
- Before and After photos may be taken at January and June weigh-ins. These pictures are for your participant file. If you are one of the top ten participants in June, 2014, your picture may be used in advertising for future \$20,000 MV Weight Loss Challenge events.
- **FINAL WEIGH IN IS SATURDAY, JUNE 21st, 2014 (TIME AND PLACE TBA)** Prizes will be awarded to the top **FIFTEEN** participants who have lost the greatest percentage of weight during the Weight Loss Challenge starting January 4, 2014 and ending June 21, 2014.
- The winners of this competition are the top **FIFTEEN** people who lose the highest percentage of weight. These people are guaranteed a cash prize of **\$7,500** for first place, **\$3000.00** for second place, and **\$2,000** for third place!! (See longer list for additional prizes)
- While you may have a team or partner for the 2014 MVWLC, all results are determined individually.

*Percentage of weight loss is based on the contestant’s total pounds lost at the finale on June 21, 2014 divided by the initial weight recorded in January, 2014.

**Only those weights recorded monthly at Kurt’s Pharmacy or the Magic Valley YMCA will be considered part of the \$20,000 Magic Valley Weight Loss Challenge official weigh in for the contest.

***Only current driver’s license or state ID permitted.

DISCLAIMER

- We recommend the supervision of a medical professional before changing or modifying your diet and exercise plan.
- **NO WEIGHT REDUCTIVE MEDICAL PROCEDURES** of any type will be permitted (this includes gastric-stapling, gastric bypass, Lap-Band, etc). Any participant found using surgical weight loss intervention would be disqualified.
- Anyone found to be weighing-in initially as one person and changing identities for subsequent weigh-ins, up to and including the finale, will be disqualified.
- You must be 18 years of age to participate.
- Prescription Medications used for weight loss are permitted, but only under the supervision of a medical doctor. All prescription medications used by contestants will require a prescription for use.
- Employees or family members of Kurt's Pharmacy and Hallmark & The Magic Valley YMCA, or any other sponsor's employees or families cannot win the money awarded at this contest. These individuals are invited to participate however.
