1. Non-refundable registration fee: **\$525** per student if paid by **April 29, 2016** and **\$625** starting **May 2, 2016**.
2. Annual publication fee: **\$100** per family
3. Parent Involvement Program (P.I.P.): **\$200** per family *(credited back upon 20 hours of service)*

**Terms:**

1. **Payments are made in ten (10) installments, August to May.**
2. All tuition payments are due and payable by the 15<sup>th</sup> day of each month. After a fifteen-day grace period, a finance charge of \$25.00 will be added to the account.
3. Any dishonored check will incur a \$25.00 fee.
4. Merdinian School reserves the right to withhold students from class, final exams, and/or school activities if financial obligations become delinquent more than 60 days. Furthermore, report cards, diplomas, and transcripts may be held until all financial obligations are met.
5. If your child is voluntarily withdrawn from school, then the tuition for the remainder of that month shall be forfeited.
