



## U.S. Department of Energy Categorical Exclusion Determination Form

Project Title: Environmental Field Plot Development and Sample Collection from Field Site Locations on the SRS

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken/South Carolina

Proposed Action or Project Description:

One or more field plots will be established to grow plants native to the SRS using seeds. A temporary PVC-framed greenhouse will be placed over the area to protect the seeds from predators such as birds or small mammals. Seeds will be watered with water obtained from 772-27B. Samples of these plants and wild plants, as well as soil, will be collected from field site locations on the SRS. Samples will undergo processing by measurement of UV/NIR spectra. Tissue samples may be preserved in the field using RNAlater, or will be preserved in the lab using liquid nitrogen. Samples may be placed on dry ice in coolers in the field before transporting them back to the lab.

This proposal would not threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of Appendix B to Subpart D of 10 CFR Part 1021; involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements.
