## FREDERIC N. SMALKIN

Judge Frederic N. Smalkin was born in Baltimore, Maryland. He attended the McDonogh School for 12 years, and he received his B.A. degree from the Johns Hopkins University, Phi Beta Kappa and Distinguished Military Graduate. He was commissioned a Second Lieutenant, Ordnance Corps, Regular Army. He attended law school at the University of Maryland, where he obtained his law degree (J.D.). On graduation, ranking first in his class, Judge Smalkin was made a member of the Order of the Coif.

Judge Smalkin began his legal career as law clerk to the late Honorable Edward S. Northrop, then Chief Judge of the United States District Court for the District of Maryland. After leaving the military, Judge Smalkin entered private practice for a time, before being appointed as a United States Magistrate (now Magistrate Judge) for the District of Maryland, concentrating on expanding the role of Magistrates in civil litigation. He served as Magistrate from 1976 to 1986, when he was nominated by President Reagan, on August 15, 1986, to serve as United States District Judge for the District of Maryland. Confirmed by the Senate on September 25, 1986, Judge Smalkin was commissioned on September 26, 1986, taking office on December 1, 1986. He became Chief Judge on October 19, 2001, serving as such until January 6, 2003, and becoming a Senior Judge on January 8, 2003.

Admitted to the bar of the Court of Appeals of Maryland, Judge Smalkin is also a member of the bars of the U. S. District Court for Maryland, U. S. Court of Appeals for the Fourth Circuit, U. S. Supreme Court, and U. S. Court of Appeals for the Armed Forces. In December, 2003, Judge Smalkin was elected to membership in the American Law Institute.

Judge Smalkin has taught for many institutions and organizations, including the FBI Academy, the Trial Advocacy Institute of the University of Virginia Law School (which presented him with the William J. Brennan, Jr., faculty award), and Wilmington College, where he created and taught a course in aviation law. He was Senior Judicial Fellow and Lecturer at the University of Maryland School of Law, where he was voted Teacher of the Year and, twice, Adjunct Faculty Member of the Year. Judge Smalkin has also been a member of the practitioner faculties of the Johns Hopkins University Carey School of Business and the Johns Hopkins School of Medicine, where he has been selected "Best of Hopkins" instructor in the MBA in Medical Services Management Program. He instructs first and second year Johns Hopkins medical students as a core faculty member of the Patient, Physician and Society Program.

Judge Smalkin is now Jurist-in-Residence at the University of Baltimore School of Law, where he teaches courses in sales and leases, commercial law, business organizations, estates and trusts, evidence, and English legal history. He was awarded the 2007 James A. May Award, by vote of the Student Bar Association, for excellence in teaching and mentoring, and he was awarded the Saul, Ewing Prize for excellence in teaching transactional law in 2009. He is currently reading for an LL.M. in maritime law from the University of London. He is the author of over 350 published opinions and co-authored a law review article with his son, The Market For Justice, The "Litigation Explosion," and The "Verdict Bubble": A Closer Look At Vanishing Trials, 2005 Fed. Cts. L. Rev. 8 (August 2005)
