Speaker Biographies

Larry Smith, Vice President Risk Management, MedStar Health

Since February 2001, Larry L. Smith, JD has served as vice president of risk management services for MedStar Health, the largest community-based not-for-profit healthcare provider in the Baltimore-Washington, D.C. area. Serving also as president of both MedStar's Cayman-domiciled captive insurance company and its D.C.-domiciled risk retention group, Larry is responsible for the design, implementation and administration of a broad and comprehensive risk management, self-insurance and commercial insurance program.

Before assuming his role with MedStar Health, Smith spent three years as the vice president and chief risk officer for UCSF Stanford Health Care in San Francisco, California. There he developed and implemented a series of insurance and self-insurance programs, including a captive insurance company to meet the needs of a newly formed healthcare system that combined the academic medical center programs of both Stanford University and the University of California Medical Center at San Francisco.

Neal Brown is an AV-rated trial attorney and a founding partner of Waranch & Brown, LLC. He has devoted his career to defending hospitals and health care providers in medical malpractice and licensure issues.
