## Procurement Strategy for Aboriginal Business

The Procurement Strategy for Aboriginal Business (PSAB) is administered by the Department of Indian Affairs and Northern Development (DIAND). If you are interested in contracting with the Government of Canada, please provide the information requested below. Responding is voluntary, but may increase your business opportunities.

PSAB was created to help Aboriginal businesses do more contracting with the Government of Canada, largely by allowing government contract opportunities to be reserved for qualified Aboriginal businesses, and in some cases making it mandatory that contracting opportunities be reserved for Aboriginal businesses. Large departments and agencies have annual goals for contracting with Aboriginal businesses. Annually, the Government of Canada awards more than 42,000 contracts totalling more than \$15 billion.

To help the Government of Canada determine if there are Aboriginal businesses with the capability to respond to specific contract opportunities, DIAND maintains a directory of Aboriginal businesses. If the Aboriginal Business Directory indicates that there are capable Aboriginal businesses, the contract opportunity may be reserved for Aboriginal businesses, and in some cases only the Aboriginal businesses listed in the Aboriginal Business Directory will be invited to submit proposals.
