



## 2006 IADD PEAK AWARD Official Nomination Form

For the 30th consecutive year, one of our industry's finest will be presented with the IADD PEAK Award.

Previously known as "Package Printing Man of the Year" and "packagePRINTING Diecutter/Diemaker of the Year," the award has evolved to focus on the person (or team of people) who has made the most positive impact on our industry in recent times. Demonstrating Passion, Excellence, Achievement and Knowledge (PEAK), the recipient stands as a fine example to our industry colleagues. To better reflect the broad scope and global nature of processes represented by IADD membership, this year the association will stand alone in presenting the award. This prestigious award continues to be one of the most coveted in our industry.

Nominations are currently being solicited. All employees of IADD Patron, Standard and Affiliate member companies and IADD Individual members are eligible, provided the member company or individual is in good standing. To nominate your choice for the IADD PEAK Award, simply complete the form on the reverse side of this page.

Ideal candidates must have demonstrated a unique, meaningful, or emerging contribution to the diecutting/diemaking industry, or should have in some way influenced the industry in a positive manner over the past few years. This contribution could be in the form of

technology, hardware systems, methods, association development and betterment, education, or through some other significant contribution. Ideal candidates should, but are not necessarily required to, have shown a pattern of active participation or intent to participate within the IADD to further the industry as a whole.

This award should not be considered a lifetime achievement award, nor should it be considered a service award. Past recipients are eligible if they meet the above criteria.

Sufficient information must be given regarding the candidate and the reason for the nomination in order for the selection committee to make an informed decision. Lack of sufficient information reduces the chances of the candidate.

The recipient will be selected by the IADD Awards Committee, which is composed of the immediate past president, three (3) past recipients of this award, and the most recent Presidential Award winner. All nominations will be considered equally, and decisions will be made on the basis of the information supplied. The award recipient will be announced at the annual meeting of the IADD and featured in a cover article in an upcoming issue of *The Cutting Edge*.

Nominations must be received by August 18, 2006.
