Animal Issues & Protection

Animal welfare is a term usually used to describe the well being of animals. However, it can also refer to the issues involved in making decisions about how animals are cared for and raised. Although there are laws and codes that require and recommend a minimum level of care for animals, some people believe that these are not enough.

Animal welfare issues can raise questions around the use of animals in settings other than farms, stables or homes. Animals can also be used for transportation, recreation and entertainment. Animal Protection Law

All Canadian provinces and territories have animal protection laws. These laws deal with animal welfare issues and animal protection. The federal government deals with animal protection through the *Criminal Code*, the *Health of Animals Act*, and the *Meat Inspection Act*. Provincial or territorial laws include specific standards of care that animal owners must follow while the *Criminal Code* does not. In Alberta, the *Animal Protection Act* protects animals in distress.

Best Practices

While not law, the Codes of Practice are nationally developed, voluntary guidelines that provide requirements from current legislation and recommendations for best practice in the care and handling of farm animals. Examples from different Codes of Practice are referenced on many of the Need to Know cards on the *Virtual Apprentice 2020* website. The Codes provide specific information about requirements, expectations and standards for the care of farm animals.

Similar to the Codes of Practice for farm animals, the Canadian Veterinary Medical Association produces Codes of Practice for dog kennels and catteries. Examples from these Codes are also referenced on many Need to Know cards.

Codes of Practice are updated at various times. For example, the Horse Code of Practice is being updated and is expected to be released in 2013. A survey will be used to gather input from horse owners. Why do you think a survey is used before development of a new Code is started?


