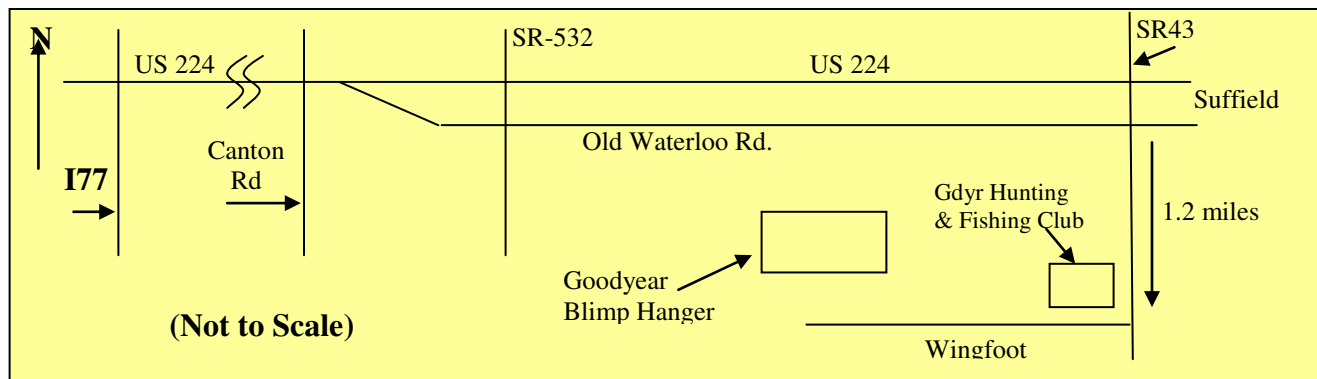
THE PRESIDENT'S REPORT - Chip Bodnovich

Constitution Committee Recommendations

The following are the Constitution Committee's proposed amendments to the GSC Constitution and By-Laws. Existing article verbiage is listed, followed by the recommendation with changes highlighted in **bold** font (also red for color versions). Constitution and By-Law amendments voting will take place at the January 2010 Business Meeting.

A4.4 At least five (5) business days before the meeting, notice of all regular and special meetings of the GSC shall be mailed to the last known address of each member entitled to receive such notice. The inclusion of a *Notice of Meeting* in an official GSC publication mailed/e-mailed within the required time will be deemed to comply with the provisions.

A4.4 At least five (5) business days before the meeting, notice of all regular and special meetings of the GSC shall be mailed/**e-mailed** to the last known address of each member entitled to receive such notice. The inclusion of a *Notice of Meeting* in an official GSC publication mailed/e-mailed within the required time will be deemed to comply with the provisions.

A5.2 The *Officers* and Ski Queen shall be elected by the members present at the regular April business meeting and shall assume their office at the close of the April meeting.

A5.2 The *Officers* and Ski Queen shall be elected by the members present at the regular April Business Meeting and shall assume their office **at the close of the May Officers Meeting. Training and transition between like Officers should occur between the April Business Meeting and the May Officers Meeting. Both incoming and outgoing Officers are expected to attend the May Officers Meeting.**

A6.1 One copy of the Constitution, By-Laws and Policies will be mailed/e-mailed to all new-member households and made available at all business meetings.

B1.2.3 Be directly responsible for the Social Committee.

B1.3.2 Provide a **financial** report at each business and *Officers* meeting.

B1.3.6 Be responsible for issuing annual membership cards.

B1.3.6 Be **directly** responsible for issuing annual membership cards.

B1.5.2 Have full responsibility for all trips sponsored by the GSC.

B1.5.2 **Be directly responsible** for all trips sponsored by the GSC.

B1.7.1 Be responsible for all merchandise sold through the GSC.

B1.7.1 Be **directly** responsible for all merchandise sold through the GSC.

B8.1.4. Available Options Upon Club Dissolution

With the dissolution of the GSC, a notice will be included in the last *Ski News* mailing stating that there may be several options available for disbursement of active member funds.

1. Funds may be distributed at a regular or called meeting;
2. A check may be mailed to the last address of record;

B8.1.4. Available Options Upon Club Dissolution

With the dissolution of the GSC, a notice will be included in the last *Ski News* mailing/e-mailing stating that there may be several options available for disbursement of **Active Member** funds.

1. Funds may be distributed at a regular or called meeting, **or**
2. A check may be mailed to the last address of record.

B9.2 Any person collecting funds for any activity of this GSC shall be prepared at all times, upon request, to a make full and complete accounting of same to all *Officers*.

B9.2 Any person collecting funds for any activity of this GSC shall be prepared at all times, upon request, to **make a** full and complete accounting of same to all *Officers*.

The creation of another by-law article:

B9.8 Supplemental appointed positions may be developed, such as Newsletter Editor, Webmaster, Race Chair, etc., based upon the needs of the Club as determined by the Officers. Supplemental positions will be voted on by the Officers for both need and appointee. Any reimbursement criteria for these positions should be included in the GSC Policies.

Additionally, there is some cleanup on the GSC Policies wording. The content remains, but the use of the phrasing "Profit or Loss Statement" is being eliminated, with the more appropriate term "Balance Sheet" used instead.

Thus the C27 policy will now read as:

C27 A **Balance Sheet** must be turned into the Treasurer within 6 weeks upon completion of the trip/event. **Balance Sheet** folders should be reviewed by the Trip Chair for trips, or the Vice President for social events, PRIOR to submitting to the Treasurer.

The GSC Policies revision history will contain the original phrasing.

Unless otherwise noted, all prices are "per person." All trip(s) reservations require a signed application with payment. Make all checks payable to GOODYEAR SKI CLUB.

CANCELLATION AND/OR CHANGES: Goodyear Ski Club reserves the right to: (1) withdraw the trip, (2) refuse, at any time, to accept or retain any person as a trip participant; and/or (3) prior to departure, make changes in published itinerary whenever, in its sole judgement, conditions warrant.

ROOMING PREFERENCES: Due to the nature of our trips, the number of participants, the bedding configuration, and the accommodations secured for the trip participants, the Goodyear Ski Club cannot guarantee that the requested rooming preferences will be provided.

SINGLE SUPPLEMENT CHARGES: Room rates are based on double occupancy. If you are a single participant, without a roommate preference, every effort will be made to find you a roommate. If this is not possible, you will be required to pay any single supplement charges that may be imposed.

RESPONSIBILITY: Goodyear Ski Club is acting as the applicant's agent and will not be liable for any loss or damage to baggage or property, or any personal injury, or any other loss occurring during or occasioned by applicant's participation or lack of participation in a trip. Goodyear Ski Club will not be responsible for any cost increase(s) due to increases in local, state or Federal taxes, fuel surcharges, etc. Any participant under 18 years of age must be accompanied by a parent or guardian.

REFUNDS: Applicant will receive a full refund if the Goodyear Ski Club cancels a trip, except and unless such cancellation is necessitated or caused, either wholly or in part, by applicant's cancellation or failure to make timely payment. 1. Where applicant cancels at any time and trip departs 100% filled, the applicant may be entitled to a full refund, less a \$5.00 service charge on any one-day trip; a \$15.00 service charge on any weekend trip; or a \$25.00 service charge on any trip over 3 days. 2. Where applicant cancels and the trip departs less than 100% filled, applicant may be liable for the entire cost of the trip, including deposit, final payment and/or balance due. 3. Applicant shall be liable to Goodyear Ski Club for any monies expended or paid by Goodyear Ski Club over and above payments made by the applicant to Goodyear Ski Club.

RELEASE: In consideration of being permitted to participate in trip activities, by signing the application, I, as an individual, hereby release the Goodyear Ski Club, officers and agents, from all liability for injury, death, damage or loss resulting from such participation. I understand the dangers inherent in the trip activities and acknowledge that I have had an opportunity to make all necessary inquiries regarding the transportation and facilities involved. I intend this release to be binding on my heirs and personal representatives. If I am the parent or legal guardian of a trip participant, I intend the above release to be applicable to the participant as well as to me.

FUEL SURCHARGES. The Goodyear Ski Club may not have been notified of any additional fuel surcharges to the contracted transportation at the time this release was prepared, but an increase can occur at any time before trip departure. It is the responsibility of the participant to pay any such increase. Participants having any questions regarding this policy should contact their trip leader.

NSF CHECK. For any check returned for insufficient funds the participant will be assessed a \$25.00 minimum return check fee, plus daily penalties. The return of any check will be cause for cash payments to be made to the GSC Treasurer. If checks are returned for insufficient funds, the treasurer shall notify the participant and allow him/her fourteen (14) days to cover the check. If funds have not been paid within the 14-day period, the member may lose his/her position on any GSC trip or activity.

POST-DATED CHECK. No post-dated check(s) will be accepted for any GSC trip.

TRIPS OUT OF THE COUNTRY – You must have a current passport, which does not expire until 6 months after your scheduled return. If you have been convicted of a crime – including D.U.I., you may be refused entry into the subject country and should contact the country's embassy or Consular General for the proper procedure/clearance. Goodyear Ski Club is not responsible for the denied entry.

****ASSOCIATE TRIP MEMBER** -- To protect the Goodyear Ski Club's non-profit status, each non-member is charged an Associate Membership fee based on a non-refundable fee structure of \$5.00 for each 1-day trip, \$10.00 for each weekend trip and \$25.00 for a trip longer than 3 days. This fee only allows an individual to participate on current season ski trip. Within one month from the ending date of the respectable trip, the associate fee may be applied toward full membership. The fee does not entitle the associate member to receive the monthly Newsletter or any other Club benefits. Associate fee will be in effect after the trip is open to non members.

NOTE: NOT INCLUDED -- Any items not specifically mentioned as part of the trip, such as meals, phone calls, transportation to point of departure, items of a personal nature, fees charged by airlines for checked baggage, etc.
