Rates and Cancellation and No-Show Policy

The undersigned acknowledges and agrees that all rates quoted for services provided by Boston Elite Coach are estimates only. Final charges assessed upon service completion will be based on the actual service provided.

No Show and Cancellation Policy

Cancellation of sedans within (6) hours of scheduled pick-up will result in a full charge equal to the base fare price of the trip plus the 20% service fee.

A 'no show' fee equal to the base fare price of the trip plus 20% service fee plus applicable wait time fee will be charged when the passenger fails to arrive at the designated location. To avoid a 'no show' fee call 1-781-213-5400 if you cannot locate your sedan.

Cancellation of motor coaches with less than 1 week notice will be charged the vehicle hourly minimum.

Cancellation of vans/minibuses with less than 1 week notice will be charged the vehicle hourly minimum.

Cancellation of limousines with less than 1 week notice will be charged the vehicle hourly minimum.

Cancellation of Meet and Greet service with less than (24) hours notice will be charged at the full rate.

Other Policy

In the event that you become delinquent or default in the payment of any amounts due and owing Boston Elite Coach over 60 days, Boston Elite Coach will place your account on credit hold and charge your credit card on file for the balance of your account including any finance charges.
