These include the Reinventing Planning paper which set out the principles for New Urban Planning in 2006, the commencement of the State of the Commonwealth Cities programme in 2009, the Colombo Declaration on Sustainable Development from CHOGM in 2013, the UN-Habitat: International Guidelines on Urban and Territorial Planning approved at Governing Council April 2015 and the CLGF Gaborone Declaration from earlier this year. Whilst these documents were not necessarily prepared to address the SDGs, they do offer guidance as to how a sustainable future can be planned for.
