





Daily Itinerary

March 14 - Depart USA

Today you will depart from the USA to Tel Aviv, Israel. Meals served in flight.

March 15 - Arrive in Tel Aviv

Arrive at Ben Gurion International Airport in Tel Aviv and be transferred to your hotel in the Tel Aviv area for check-in, dinner and a good night's sleep.

March 16 - Caesarea Maritima, Mt. Carmel, Megiddo, Nazareth, Tiberias

Wander through the Roman aqueduct and theater at Caesarea, a center of early Christianity. Here, Cornelius became the first Gentile convert to the new covenant (Acts 10) and Paul was imprisoned before being taken to Rome for trial (Acts 23). Travel up to Mount Carmel where Elijah defeated the prophets of Baal (1 Kings 18). After coming off the mountain, drive the ancient caravan route to Tel Megiddo where 20 different cities lie superimposed upon each other. Continue to Nazareth, Jesus' boyhood home (Matthew 2). Finish your day by entering the coastal city of Tiberias on the shores of the Sea of Galilee to check into your hotel, dinner and overnight.

March 17 - Ancient Boat, Golan Heights, Caesarea Philippi, Tel Dan, Peace Overlook, Jordan River Baptismal

At Kibbutz Nof Ginosar, you'll learn about the "Ancient Boat", a rare example of the kind of boat in which Jesus would have sailed. Travel through the Golan Heights and better understand their strategic importance to the security of Israel. Visit Caesarea Philippi, where Jesus traveled with His disciples and where nearby Peter made his great confession to Jesus, "Thou art the Christ, the Son of the living God" (Matt. 16). Nearby is Tel Dan, one of ancient Israel's boundary markers - "From Dan to Beersheba". Take in the panoramic view from the Peace Overlook. End the day with a stop at the Jordan River for a time of spiritual blessing.

March 18 - Mt. of Beatitudes, Capernaum, Tabgha, Fish Lunch, Boat Ride, Jordan River

Visit the peaceful Mount of Beatitudes that overlooks the Sea of Galilee. On this hill, Jesus preached the Sermon on the Mount (Matt. 5-7). Travel to Capernaum,



the center of Jesus' ministry in the Galilee. Visit the synagogue that stands on the site where Jesus taught. Recall His teaching and preaching the gospel of the kingdom (Matt. 4). Stop at Tabgha, where the feeding of the 5,000 is remembered at the Church of the Loaves and Fish (Luke 9). Enjoy a St. Peter's Fish lunch at the Ein Gev kibbutz. Afterwards, you will enjoy a beautiful boat ride across the Sea of Galilee and then stop at the Jordan River for a time of spiritual blessing.

March 19 - Jordan Valley, Qumran, Masada, Dead Sea, Jerusalem

Travel through the Jordan River Valley, the route often taken by Jesus and others as they traveled to and from Jerusalem. Stop at Qumran, site of the Dead Sea Scrolls discovery, to discuss the mysterious community of the Essenes who once lived on the shores of the Dead Sea. Enjoy a visit to Masada, the spectacular mountaintop fortress built by Herod and famous as the last stronghold of the Jewish rebellion against the Romans. Ride the cable car to the top to explore the fortress. Peer down upon the remains of the Roman camps and siege ramp below. Stop at the shores of the Dead Sea, the lowest spot on earth, where those who desire may take a quick dip in the mineral-laden waters. After traveling through the Judean Wilderness, enter the holy city of Jerusalem where we can take a few minutes to look out over the city before arriving at our hotel for check in, dinner and a good night's sleep.

March 20 - Bethlehem, Shrine of the Book Museum - Model City, Mt. Zion, Upper Room, King David's Tomb, Caiaphas's House

We begin our day with a visit to Bethlehem (Luke 2), where our Lord was born. Understand better the Jerusalem of Jesus' day with a look at the First Century Model of the City of Jerusalem, now housed at the Israel Museum. The museum itself houses 10,000 years of archeological artifacts. Also visit the Shrine of the Book, where the Book of Isaiah, discovered among the Dead Sea Scrolls, is displayed. Travel to Mt. Zion where you can stand in the Upper Room, revered as the place of the Last Supper (Mark 14). View the site of King David's Tomb. Walk through some of the ancient rooms of Caiaphas' the High Priest's house beneath the Church



of St. Peter in Gallicantu. Here, it is believed by many, Jesus was held overnight before His crucifixion (Luke 22).

March 21 - Mt. of Olives, Garden of Gethsemane, Rabbi's Tunnel, Pool of Siloam

Stand atop the Mount of Olives as Jesus did and enjoy a remarkable view of the "Golden City" of Jerusalem. Forty days after His resurrection, Jesus ascended into heaven from the Mount of Olives (Acts 1). Enter the Garden of Gethsemane, where Jesus went to pray after the Last Supper and was arrested (Matthew 26). Follow the Herodian Support Wall and walk on First Century pavement in the Rabbi's Tunnel. Stand on the steps of the Pool of Siloam, where Jesus healed the blind man (John 9).

March 22 - Temple Mount, Pool of Bethesda, Via Dolorosa, Old City Tour, Garden Tomb, Gordon's Calvary

See the Temple Mount, once the site of the Temple of Solomon. View the Pool of Bethesda (John 5) where Jesus performed the Sabbath miracle. Visit Herod's Antonia Fortress where Jesus was brought before Pontius Pilate (Luke 23). Walk the Via Dolorosa, "the Way of the Cross." As we make our way through the Old City, we can enjoy the preserved, ancient culture found in the narrow streets as well as the modernized Cardo in the Jewish Quarter. Finally, sense the agony of Christ's crucifixion at Gordon's Calvary (Luke 23) and experience the exhilaration and reality of the resurrection at the Garden Tomb. At the end of your time in the Holy Land, we prepare for our return journey to the USA.

March 23 - Arrive Atlanta

Arrive in the USA with a lifetime of memories to cherish.



Robin and I would like to ask you to join us and an exciting group of believers as we journey to the Holy Land and retrace the footsteps of our Savior. This ten day pilgrimage will be life changing as you walk

where Jesus walked and follow the lives of His disciples and the patriarchs of the Old Testament. You'll experience moments in the Holy Spirit as you travel through this ancient land. Our time together will be filled with fellowship, fun and the study of God's Word. We'll experience times of praise and worship as we visit the dearest sights of our faith. We hope you'll say "Yes" and make the decision to join us next March as we walk where Jesus walked!

PAYMENT:
