## **CLUB ACTIVITY DAY REPORT**

As everyone would be aware the Committee has recognized that many members have requested more activity days where practice training and member help days are included on the yearly program.

The first of these was held on October 26th. The day dawned yet another perfect day for a club activity. The tests offered where innovative in that they are from the USA

Dressage Federation. These are tests designed for the rider to be judged rather than the horse. An excellent aside to the normal dressage test riding, with excellent feedback for riders to help them improve. Also offered where HRCAV tests for those people wishing to try a different track than they normally ride...breaking the boredom of the same tests.

Several members attended including some young horses for the trip and a ride outside the arena. Thank you to Amanda Lock for solo arena erection, Nat Goldsworthy for judging the event and to Kristy Boord for penciling and scoring. ### A Judge's perspective

On Sunday 26 October 2014, I had the privilege of judging MSEDC members riding the United States Equestrian Federation (USEF) Rider Tests (as well as some HRCAV ones) ably assisted by penciller extraordinaire, Kristy Boord!

The tests are quite different from what we are used to judging in Australia (and to ride I would imagine). The immediately obvious difference (from a judge's perspective) is that although the tests are divided up by numbered movements, the same as EA & FEI tests, there is no score given for the individual movements. Instead, five 'Collective Marks' out of 10 are given at the end. Decimal marks can be given too (e.g. 7.3, 5.8 etc.) although as Kristy was scoring as well as pencilling I was not brave enough to go nuts with the decimals and stuck to .0 or .5!

The Collective Marks are given for Rider's Position, Rider's Correct and Effective Use of the Aids, Horse's Response and Performance, Accuracy of the Exercises and Harmony between Rider and Horse. There is a coefficient of 2 for each mark and then the total score (e.g. 67.9) becomes a percentage (= 67.900%) expressed with 3 decimal places.



relevant comment for each movement on the test sheet so that I could use those notes to give accurate collective scores and comments at the end (I have a woeful memory). But as we progressed through the draw it became easier to remain focused on the directive ideas provided with each test and by the end I was just making the odd short note if there was something specific I felt should be reflected and/or noted.

Overall, the tests were really well ridden, although they did highlight that many riders could sit more symmetrically and in balance with their horses (exactly their purpose I assume). Members rode training, 1 and 2 level tests and everyone seemed to enjoy riding something a bit different. My highest USEF score of the day went to Kristine Blacksell with 70.000%. Hopefully, I was able to provide some useful feedback to each rider. Thanks MSEDC for the opportunity to be involved in this activity; it was another, casual, fun, well-run day! Nat Goldsworthy

#### Changes to the Scoring of EA Freestyle tests

The numbering of the collective marks in the Novice, Elementary & Advanced F/Styles were not consecutive with the numbering of the technical movement up the top and it caused an issue with the scoring when calculating the total results. Please contact EA or your Club Officials for changes necessary.

#### South Australian EA Clubs meeting

Two or our committee attended the SA Clubs meeting in Adelaide on Friday the 7th of November. It is imperative that our club continue to be represented at these meetings to be involved with co-ordination of competition dates, be included in the EA Calendar, have interaction with other club reps, bring development ideas and united front for presentation of ideas for South Australian clubs.

#### The National Dressage Championships have been run and won

We offer our congratulations to all the SA horse and rider combinations that made the trek to the east coast. Lots of great successes too......well done.

#### EA Judges

As you are aware the reaccreditation process comes due by 31 March 2015 and covers a 3 year period this time, and this time only. From 2015 it will be on a 2 year cycle again. The following info is to advise the process:

#### Open Rule Book Test

Once again the ORBT will be available online. It will also be available in hard copy for those who don't want to do it online. The ORBT this year will have generic questions that all judges will be required to answer. There will also be some level specific question that you will be required to answer relevant to your level.

We anticipate that the ORBT will be up on the EA website during January and you are urged to complete the process sooner rather than later.

#### **Documentation Needed**

Once your documentation has been received by the National Office you will automatically have your accreditation extended to 30/6/15. This will give time for the NO to check everything. Keep in mind that the NO will be very busy during this time as all Sports will be reaccrediting at the same time.

To be ready for the process please make sure that you have the following information ready to send:

\*\*\* All judges H to A - Details of the compulsory seminar at your level that you attended between 1/4/12 and 31/3/15

All judges H to A - Details of the compulsory workshop or additional seminar that you attended between 1/4/12 and 31/3/15

All YH Judges - Details of the compulsory YH seminar that you have attended between 1/4/12 and 31/3/15

**\*\*** All judges F to A -Details of having Judged at 6 Official <u>events</u> at your highest judging level e.g. If you are a B level judge then judging to be at Inter 1

All judges F to A - Details of having judged at 3 other events at any level up to your highest level - refer to 9.15.1

\* H level judges to provide details of having judged at 6 participation/restricted Club events or Eventing Dressage or Interschool

All Judges H to A - Details of accruing a minimum of 18 points from the Activity table (see 9.25 page 94 of 2014 Rule Book and the modified Updating Diary attached) during the period 1/4/12 to 31/3/15

#### \*\*\* Seminars & Workshops – All Levels

Seminar process every 2 years has to continue so if you did a seminar in 2011 or 2012 you should have done another one in 2013 or 2014 (this year) and so it goes on (as previously advised in March 2014) Workshop process on the alternate year has to continue as well

**\*\* Note to Judges that have upgraded during the reaccreditation process** – The judging of Official events at your highest level will be pro-rated based on your level

\* Note to H level judges – The judging requirement will be pro-rated against the time that you have been an H level judge.

#### Summary of Business of the meeting of the Australian Dressage Committee Sunday 30 May 2014

#### Dressage Strategic Planning Taskforce/Rider – Club Survey

The Chair reports that the second meeting of this Taskforce held the day after the May ADC meeting had made progress with ideas about "Marquee events" to promote the sport of dressage at multi-discipline events. The EA Board has also picked up this concept and will put resources into it developing a Manual to assist OCs of major events. Thank you to all who responded to the Rider/Club Survey – the ADC has looked briefly at the results but now needs to analyse all of the valuable information that has been provided. There is no doubt that this analysis will inform the Dressage Strategic Taskforce as well as have an impact on the agenda of the ADC in 2015.

#### Pacific League Final 2015/16

The meeting made a decision on the venue for the League Final for both 2015/16 and 2016/17 season. It has been sent to the Board for approval.

#### **High Performance Report**

Chris Webb (HP Manager) and Julia Battams (NPD) gave a report on WEG 2014 preparations for both Dressage and PE Teams. Chris Webb also outlined a draft of the **High Performance Plan** (General and Discipline Specific) for the next 4 year period which will be finalised by end of 2014.

The YH selection process for the FEI World Young Horse Championships was raised and agreed to review the policy schedule of timeframes to better incorporate European based young horses in terms of their qualification process.

The desired PE competition program for the future was also raised and it is proposed that at least very second year, Australia would conduct an international CPDI. This would provide judge and steward opportunities in AUS and NZ.

#### Para Equestrian Report

Sue Cunningham provided a detailed report from the FEI Para-Equestrian Technical Committee Meeting, of which she is a member, held in Mannheim, Germany on the 1<sup>st</sup> - 2<sup>nd</sup> May. The 2015 Education Calendar should be available by the 1<sup>st</sup> October 2014. There should be at least one exam and one refresher seminar offered to FEI PED judges every year.

In 2015 a Para forum will be held to discuss major rule changes planned for 2017. The hosting NF is still to be named. Additional EA PE tests are still under consideration.

#### **NEM Report**

National Education Manager Ben Harris, gave a report on the FEI courses conducted in each discipline, including courses for stewards. He also confirmed that all national reaccreditation processes to remain on 2 year cycle, but for office efficiency will synchronise all officials in all disciplines as from 31.3.15

Also discussed that at last ADJC. JE/Mentors National meeting it was agreed to develop a National Calendar of Judge educational activities so that cooperation between states can develop and candidates can see where courses are available throughout Australia (if they have missed one in their own state.) This is being coordinated by the ADJC and is already available to each State Judge Coordinator/Committee. It will ultimately be available on the EA website.

#### Young Horse Rules

The TD report for the March Australian Young Dressage Horse Championships (DJWTS) led to discussion about the 6YO Pony Test – this is still too difficult so a revised easier version will be developed for the season starting on 1 August 2014. In addition the Judge requirements for the Pony Classes were reviewed in order to give more opportunities to Australian accredited YH judges.

NB. The revised Rules for 1 August 2014 season have been sent to all State Dressage Authorities and the 6YO Pony test has been finalised and is on website .

#### **EA Membership Review Outcomes**

As yet the EA Board has not finalised the outcomes of the Review.

#### **National Amateur Owner/Rider Division**

This has been very successfully (and enthusiastically) taken up in NSW and Queensland. Other states will have an opportunity to provide further feedback at ADC/SDA meeting in September

#### **Stewards – Fact Sheet on Role of Stewards**

On the basis of the paper prepared with assistance of the FEI Steward-General, ADC agreed to update the Rule Book with more explanation on the role of stewards and also to prepare a Stewards Fact Sheet to be available to riders and OCs. This could also be promulgated at National and State Squad Clinics.

The ADJC has had a query about the following movements in the Advanced 5.2 Movement 14: KX on the diagonal Near X develop very collected canter working half pirouette approx. 2 metres Proceed collected canter Movement 18: HX on the diagonal Near X Develop very collected canter working half pirouette left approx. 2 metres Proceed collected canter

The movement is quite clear it says 'KX" and "HX" - near the centre line would be between KX and HX - not beyond X. It is expected that for the highest mark it must be at or before X.

If the rider crosses the centre line by more than 1 metre <u>before starting the pirouette</u> this will be considered an Error of Course. Given that it is a mirror image movement the bell should be sounded and the rider advised so as to avoid it happening the next time.





## NATIONAL ADULT AMATEUR OWNER/ RIDER DIVISION.

### FACT SHEET

Criteria

MID SOUTH EA DRESSAGE CLUE

In order to qualify as an amateur owner rider, all riders must declare that they meet the following criteria:

1. The rider must be a Competitive member of their state branch of Equestrian Australia

2. To qualify as an Amateur Owner/Rider the rider must not have competed in an FEI Sanctioned CDI (PSG- GP ) or CDI-W in the prior 3 calendar years.

3. The horse must have a life registration with Equestrian Australia.

4. The horse/pony registration lodged with Equestrian Australia must reflect the name of the amateur owner rider as owner of the horse. Leased horse are only permitted if the registration papers reflect the lessee as the "owner"

5. An amateur owner rider must not have sponsorship, or remuneration (excluding prize money) above the value of \$500/annum for any services connected with the breaking, training and riding of any horse or pony in the last 3 years.

6. An amateur owner rider's principle source of income is not obtained from sponsorship, breaking, training, riding or coaching any horse or rider.

7. The horse/pony must be primarily ridden and trained by the rider/owner with only periodic ridden assistance by person(s) other than the owner. Specifically the horse/pony must not have been ridden or trained by anyone, other than the owner, from the closing date of entries to the day of the event, for any event in which the rider wishes to compete as an amateur owner rider.

8. The rider must be aged 21 and over – can enter in the calendar year in which they turn 21.

#### Organisation

• The Division is for Official Competitive classes. The Organising Committees may run this Division at any level (ideally at all levels Preliminary - GP) and it can be run either within the class or separately.

- Organising Committees may choose to designate the Amateur Owner Ride on the draw.
- For a State/Regional/Club Leader Board it would be ideal to select a number of events at which scores will count towards the annual Leader Board.
