#### 7. TERMS AND CONDITIONS

### **RENTAL COMPANY: CUBACAR**

#### 1. RENTAL CONDITIONS:

- **1.1.** The vehicle must be driven only by the people specified in the Rental contract. For any breach of the contract the rental company will apply a penalty of 50.00 CUC or the contract could be cancelled. If client leaves the car under responsibility of additional driver not specified on the contract, the client will loose the right of the coverage offered by CUBACAR in case of any accident and he will be responsible with the payment of all damages.
- **1.2.** The client can have additional drivers. In this case apply a rate of 3 CUC per driver per rental day (2 driver maximum).
- **1.3.** The combustible for the vehicle should be always Special Gas. The client is responsible of correct type of gasoline to be used.
- **1.4.** In case of any accident, total or partial robbery, the client must communicate it to CUBACAR immediately and report to the police in order to know the client responsibilities.
- 1.5. Guarantee Deposit: It is compulsory to pay a deposit of 150 CUC (in cash or credit card). In case of damages over 150 CUC, the initial deposit will be collect and additionally till 200 CUC from the client, depending of the damage's amount. In case that the damage is below 150 CUC, the damage's amount will be deducted

#### 2. INSURANCE AND COVERAGE:

- **2.1.** CUBACAR offers insurance to the client as long as he fulfils with the clauses related in the car rental contract.
- **2.2.** The coverage of insurance will be of obligatory fulfillment by the client and he must pay a daily rate established at the moment of the car rental contract is done. The client is exonerated to any responsibility in the following cases

- 4.3 In all cases mentioned above the client must notify to the competent authorities immediately and in case of loss or extraction the client should show a police report with the denunciation to CUBACAR or VIAJES CUBANACAN at the moment of contract liquidation or when the event happens. In case of any accident the client should show a police report at the place of fact or from Inspector of TRANSTUR report, which it will be the way to define if client is guilty or not of vehicle damages.
- **4.4** If the client is defined as guilty, he must pay the established deductible in the CUBACAR contract
- **4.5** If the client is not defined as guilty of car damages he won't have to pay any amount.
- **4.6** The coverage protects to the client during contract validity and in case of accident up to 12 hours later of contract expiration.
- **4.7** The coverage offered by CUBACAR is not valid in the following cases:
  - **4.7.1** Total o partial robbery, accident or fire due to client negligence or violation of the laws established in Cuba or on the contract.
  - **4.7.2** If competent authorities proves the client was driving under effect of alcohol, drugs or similar and the vehicle or third people have been damaged.
  - **4.7.3** If the vehicle is being driven by people not authorized on the contract.
  - **4.7.4** If the car has more passengers than established on the contract according car category.
- **4.8** In case one of the aspects mentioned above occur the client will be considered responsible and will have to pay all damages caused to the car or third people.
- **4.9** CUBACAR will be responsible of reimbursing to third people only under limits of established coverage, which it doesn't include medical costs.

#### 3. CANCELATIONS AND NO-SHOW POLICY:

- **3.1.** It is considered NO Show when the client doesn't present to CUBACAR 3 hours after requesting the reservation.
- **3.2.** No-Show: The penalty will be 100 % of the price of one day of rental.
- **3.3.** If a reservation was confirmed and it is cancelled 24 hours before starting the service the client will be free from any penalty.

#### 4. ABOUT THE CARS:

- **5.1.1.2.** Invoice of the expenses assume by the client.
- **5.1.1.3.** Any document related to the claim.

In case that client does not provide all the information required during the period before mentioned, the claim won't be valid.

Cubanacan International B.V.will compensate clients in case that proves that expenses were made to pay damage caused to a third person or the car and the amount of the compensation isn't over the damage coverage of the client.

## **RENTAL COMPANY: REX**

#### 1. ABOUT THE CARS:

- 1.1. The cars are of mechanical transmission, with air conditioning, Air bags, Brake system ABS and CD or cassette Player.
- 1.2. Guarantee Deposit: It is compulsory to pay a deposit of 250 cuc (in cash or credit card), for all categories of cars included in our contract. Credit cards accepted are: VISA, MasterCard, CABAL (not emitted by bank from U.S.A).If there are not any damages and no additional charges, it will be returned the total amount paid as deposit.
- 1.3. The car will always be delivered with full tank at the beginning of the rent and it will be charged to the client the full tank of combustible according to the rates in Gas Oil station of the country. At time of drop off the client should return the car

with empty tank.

1.4. The car will have always full tank of combustible at the time of pick up. If the clients do not return the car with full tank, then REX will collect from the client the value of the Gasoline of the empty capacity according to the rates in Gas Oil stations.

- **1.5.** The vehicle must be driven only by the persons specified in the Rental contract.
- **1.6.** The client can have additional drivers. In this case apply a rate of 10 cuc per driver (2 drivers maximum).
  - a) Additional drivers are authorized to drive vehicle, but not to: pick up, drop off, receive devolutions in cash or request any extra days of rental. These transactions should be made by the main driver.
  - b) The car can be driven only by registered drivers.
- 1.7. If client leave the car under responsibility of additional driver for dropping of the car. REX offers coverage against damages: **Super CDW + TP (Super CDP).** It is compulsory to acquire it to be able to rent the car. This option is not registered in rental contract by paying the daily rates for each type of vehicle.. **The daily rate for this damages coverage varies depending of the car type.** 

- 2.2. Total Exemption of responsibility for damages to the integrity of the vehicle Super CDW + TP (Super CDP)
  - 2.2.1. If client accepts the Super CDP, it is freed of any economic responsibility for damages to the car. It means that in case of an accident (in which none of the terms of the rental contract is violated), the client won't make any payment. This coverage is offered without deductible
  - 2.2.2. In case of an accident the client should present to Rex a Police Report and will pay only for the damages if the report shows establishes a violation of the terms agreed in the rental contract (i.e. Drugs Consumption, alcohol, driver not registered in the rental contract)
