#### Requirements:

- (1) The fisher made the equipment purchase after July 1, 2015.
- (2) A fisher must met at least one of the following criteria to qualify for reimbursement:
  - (a) At least 50% of a fisher's income must be earned from commercial fishing offshore Santa Barbara County (Fishing Blocks 633 through 648; 650 through 663; 684 through 697; 707 through 717; 726 through 736; and 778); or
  - (b) At least 33% of a fisher's annual catch (based on weight) must be caught offshore Santa Barbara County (same fishing blocks listed above); or
  - (c) At least 50% of a fisher's annual catch must be landed at the Santa Barbara Harbor.
- (3) When evaluating applications for reimbursement, County staff may require certified verification based on fish tickets from the California Department of Fish and Game.
- (4) The equipment must be installed on the fisher's commercial boat only; one reimbursement per boat. A boat owner/lessee can receive up to \$500 in reimbursements.
- (5) Reimbursements are accepted on a first-come, first-serve basis.
- (6) Fisher may receive only \$500 within a 12-month period.

### The following MUST be enclosed for consideration of a reimbursement.

- (1) Front side of this application completely filled out.
- (2) A copy of the receipt of the purchase. The store in which it was purchased and date of purchase must be on the receipt.
  - a. California law requires that Sales Tax be remitted on all qualifying purchases. When the County reimburses individuals for goods or services and determines that an omission of tax has occurred, tax will be assessed and the amount remitted to the California Board of Equalization by the County. The tax amount will be deducted from the reimbursement to the applicant.
- (3) Current Form 1040, Schedule C, Profit or Loss From Business.
- (4) Current Substitute W-9 & Vendor Information Form.
- (5) Withholding Exemption Certificate, California Form 590
