Reservations and Payments: A completed tour application together with a deposit of \$500.00 per runner and \$200 per non-runner must be received before confirming your reservations. Final payment must be received before December 1, 2014.

Revisions: Changes to your reservation after your final payment and before February 1 will incur a \$25 change fee. Changes after February 1 will incur a charge of \$75. Reduction after February 1 in the number of nights booked may result in full penalty.

Cancellations: The deposit of \$500 per runner deposit is non-refundable. The \$200 non-runner deposit is refundable if cancelled before December 1. Cancellations made after December 1 and before February 1 are subject to a \$500 charge for runners and \$200 for non-runners. Payments are non-refundable for cancellations made after February 1. Most fares are non-refundable once ticketed but may be used for future travel on that airline within one year. Edinburgh Extension: Cancellations made after December 1 and before February 1 are subject to \$100 cancellation fee. Cancellations after February 1 will be under full penalty. Entry fees are non-refundable.
