IBCI Conference 2015

The Irish Building Control Institute is pleased to present the IBCI Building Control Conference, 2015. The Conference will afford an opportunity for those involved in Building Control throughout Ireland to network with their colleagues and receive an update on current developments.

The Conference will be held over two days in the **Malton Hotel, Killarney, Co Kerry**. Lunch and refreshments will be provided on both days, with the Conference Dinner on the Wednesday evening. A Trade Exhibition will also be held in conjunction with the Conference.

The focus with this Conference is on the changes that were introduced on March 1st 2014 in the Building Control System and the developments in the year since then.

Day 1 morning session will include an update on the Building Control legislation/Regulations and on the Construction Product Regulations. After lunch the new system of building control one year down the line will be discussed, including Engineers, Architects, CFO and BCO perspectives and the working of the new IT system.

The session will complete with a general discussion on new system.

Day 2 commences with a paper on Mica problems in Masonry followed by a presentation on legacy fire safety problems from the Celtic Tiger era.

Day 2 concludes with a Part L related talk on air tightness insulation and finishes with details of the Quali-Build Project.
