### **DIRECTIONS TO SITE HEADQUARTERS**

**FROM THE EAST:** Take Elgin-Ohare Expressway west, Exit Lake St / IL rte. 20, head west 14 miles, Turn left onto Plank Rd. Continue 10.6 miles, Turn right onto Engel Rd. Cross over the railroad tracks and make a left into the Forest Preserve entrance.

**FROM THE WEST:** Take Illinois toll way 88 east; take exit onto Peace Rd in DeKalb. Drive 15.6 miles. Turn left onto Engel Rd. Cross over the railroad tracks and make a left into the Forest Preserve entrance

## **ATTENTION EXHIBITORS**

In accordance with American Kennel Club Tracking Regulations Chapter 5, Section, 1, Amended to January 2015, dogs entered in the TDX test must have earned a TD or TDU title. Entries without a required title or certification will be accepted first. TD entries must include a certification.

THERE will be no actual scores for the TD or TDX Test, but the dog will be rated "Passed" or "Failed" and a TD or TDX certificate will be issued by the American Kennel Club confirming all dogs rated "Passed".

TELEGRAPH, telephone and unsigned entries cannot be accepted. Entries not on Official AKC Entry Forms and photocopies of entry forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

ENTRY FEES: \$70.00 (TD) & \$110.00 (TDX) (includes 50 cents Recording Fee) made payable to Glenbard All Breed Obedience Club, Inc. A Recording fee of 50 cents and event fee of \$3.00 will be required for each dog entered at any licensed or member club show, or obedience trial or tracking test. This recording fee is to be collected by the show giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only. Entry fees will be refunded within seven (7) days after completion of the Test in the event all tracks have entries or alternates have replaced entries. No entry fee will be refunded if the request is made after closing date and all tracks are not used.

ENTRIES cannot be accepted, canceled, altered or substituted after the entries close with the TD/TDX test secretary.

BITCHES IN SEASON ARE NOT ALLOWED TO RUN IN THESE TESTS.

**The Tracking Dog Test is limited to 4 tracks. (or 6 if the TDX doesn't fill) The Tracking Dog Excellent is limited to 4 tracks.** In accordance with the AKC Obedience Regulations (AKC Rule, Chapter 1, Section 17) entries in this Test shall be accepted up until the official closing date, even though the advertised limit has been reached.

A drawing will be held on Monday April 11, 2016 at the secretary's home at 6:00 p.m. to determine which entries will participate in the test. This drawing shall be completely random among all entries received except that preference shall be given to dogs which have not earned the a title

When the advertised limit has been drawn, all remaining entries shall be similarly drawn and assigned a position on the alternate list, Listed limits for each type of track is final - no exchanges are planned due to site space limitations.

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
