CONVERSATION DESCRIPTION:

Mr. Morgan called concerning the status of the STPUD's Permit 10067 (Application 11993) and a claim of pre-1914 appropriative water right covered by Statement 4677. These two water rights apparently cover year-round direct diversions totaling 4.5 cfs from Cold Creek tributary to Trout Creek thence Lake Tahoe. Statement 4677 covers 1.8 cfs, while Permit 10067 covers the remaining 2.7 cfs, for domestic, municipal, industrial, and fire protection uses.

Mr. Morgan indicated that the diversions works and treatment facilities have been mothballed or placed on standby basis for the last several years because STPUD relied on groundwater wells for its primary supply. However, the STPUD has been considering reactivating the Cold Creek diversions due to the recent problems with MTBE in the extracted groundwater. Because of the recent USEPA surface water treatment water rules for drinking water, the STPUD will be required to construct additional treatment facilities before any Cold Creek water can be used for municipal purposes.

Mr. Morgan had questions concerning the status of P10067. I informed him that all Lake Tahoe/Truckee River watershed water rights have been in "limbo" since the mid-1970's, pending resolution/quantification of the reserved water rights for the Pyramid Lake Tribe of Paiute Indians (Tribe). Notices mailed to water users in watershed in 1975 and 1976 indicate that the Tribe's case may result in loss of claim to all water by other users, including diversions under claim of pre-1914 appropriative, riparian, and overlying rights. Therefore, the STPUD will have to evaluate the risk of losing the rights prior to construction of any new treatment facilities. I informed him I could not locate any current status of the negotiations of the Truckee River Operating Agreement that reportedly may resolve the water supply issues in the Lake Tahoe/Truckee River watersheds.

I also informed Mr. Morgan that the fourth time extension for Permit 10067 expired on December 1, 1970. Protest and comments received on the petition for a fifth time extension imply that additional environmental review may be required (since the permit was issued in the pre-CEQA/NEPA period) that may result in additional permit terms and conditions (such as fish protection bypass flows in Cold Creek). The cost of environmental reviews/operational constraints will have to be considered for the economic viability of any Cold Creek diversions/treatment works.

I also informed Mr. Morgan that STPUD staff had a least one meeting with Larry Attaway and Jerry Johns of Division staff concerning the status of all STPUD water rights. I suggested that he should call Larry for additional information.

GENERAL INFORMATION PERTAINING TO WATER RIGHTS IN CALIFORNIA

There are two principal types of surface water rights in California. They are riparian and appropriative rights.

A riparian right enables an owner of land bordering a natural lake or stream to take and use water on his riparian land. Riparian land must be in the same watershed as the water source and must never have been severed from the sources of supply by an intervening parcel without reservation of the riparian right to the severed parcel. Generally, a riparian water user must share the water supply with other riparian users. Riparian rights may be used to divert the natural flow of a stream but may not be used to store water for later use or to divert water which originates in a different watershed, or return flows from use of groundwater.

An appropriate right is required for use of water on nonriparian land and for storage of water. Generally, appropriative rights may be exercised only when there is a surplus not needed by riparian water users. Since 1914 new appropriators have been required to obtain a permit and license from the State.

Statements of Water Diversion and Use must be filed by riparian and pre-1914 appropriative water users. The filing of a statement (1) provides a record of water use, (2) enables the State to notify such users if someone proposes a new appropriation upstream from their diversion, and (3) assists the State to determine if additional water is available for future appropriators.
