#### TAX INFORMATION FOR INTERNATIONAL STUDENTS

**All F1 students** have at least one US tax form to complete! Some students will only fill out a 1-page form called form 8843. You can find this form easily on Google. Others will file a Non-Resident US tax return if they had income last year.

**Please review** the flow chart at the end of this newsletter to see what tax related forms to complete and how to get help. CSU provides access to special software called Glacier Tax Prep (GTP) free of charge to those students who need to complete a US tax return for Non-Resident Aliens (international students).

Note: Tax services such as: Turbo Tax, H&R Block, others... are not designed for international tax returns.

#### **SPRING 2014 O.P.T.** (Employment Authorization) INFO SESSIONS

O.P.T. or *Optional Practical Training* is off-campus employment authorization for international student. It's a benefit of your F1 Visa. A formal application, a government fee, and other steps are required to request OPT approval. Learn the basics and ask questions if you are within 6 months of graduation. #### PERSONAL SECURITY WORDS TO KNOW!

- **1. Phishing:** Any attempt to obtain personal info like usernames, passwords, credit card info, bank account info, etc... *Ex: Unfortunately, the student lost \$1000 when he fell victim to a phishing scam; he gave his credit card number over email to someone promising to send him a new lpad.*
- **2. Scam:** Similar to phishing. Scams are everywhere. They try to fool you into believing you are spending money for a quality product or service only to find out that you have wasted money on a low-quality or non-existent product or service.

  Ex: The offer of a free 7 day cruise for \$20 is a common scam to get you to go on tours of real estate for sale.
- **3. Spam:** also known as "junk mail". Many junk emails contain scam offers and phishing programs. Delete your spam regularly, but don't open these emails.

Ex: After looking in my spam folder, there were more than 100 spam emails. One said I had inherited \$1 million from an Uncle in Ethiopia.



# Which Tax Forms Do I Use? Tax Year: Jan. 1 – Dec. 2013

### **Start here:**



SPT =

**Substantial Presence Test:** an IRS formula used to determine another aspect of your tax filing status. If you have been in the US any part of 5 *different* calendar years, you might be considered a *resident for tax purposes* and will file the same tax forms at US citizens. If you don't meet test, you are "exempt from SPT" and use the forms above. Contact ISSO if you are unsure.
