WHERE: Lancaster Catholic High School Stadium at 634 Stadium Rd, Lancaster, PA. Enter the stadium area by using Stadium Road or Clearview Ave. Both roads are accessed from Pleasure Road which is off of Oregon Pike south of Route 30.

The Run will meander through the tree-lined nearby neighborhood. Walkers will enjoy a nice stroll on the stadium track, completing 4 loops for the 1 mile walk. Afterward, everyone will enjoy a "**piece of cake**"

COST: \$25.00 per person to run or walk.
